

# Child Nutrition CSP 120118 for Commodity Processing

February 28, 2012

**SUMMARY:**

This item requests approval of CSP 120118 for Child Nutrition Commodity Processing for the 2012-13 school year.

**BOARD GOAL:**

**VI. Growth and Change...a.** Demonstrate effective and efficient management of district resources.

**PREVIOUS BOARD ACTION:**

On February 15, 2011 the Board approved the 2011-12 proposal as recommended.

**BACKGROUND INFORMATION:**

Proposers submit all of the services they provide. However, our district does not use all of the types of processing. The types used are noted on the summary sheets.

Proposals were submitted by Advance Pierre Foods, Alpha Foods, American Foods Group, Asian Food Solutions, Barrel O'Fun Snack Foods, Bosco's Pizza, Café Favorites, Cavendish Farms, ConAgra Foods Chuck Gentile, ConAgra Foods Lamb Weston, Culinary Standards, ES Foods, Good Harbor Fillet, High Liner Foods, Icelandic USA, Integrated Food Service, Jennie-O Turkey Store Sales, JOY Foods, JTM Provisions, Kings Delight, Land O'Lakes, Lings, Lux Bakery, MCI Foods, McCain Foods, Nardone Bros Baking Co, National Food Group, Pilgrim's Pride, Quantum Foods, Schwan's Food Service, JR Simplot, Trident Seafoods, Tyson, and Wawona.

Pricing was submitted as a Fee for Service or Net off Invoice. It will depend upon the commodities actually processed as to how much will be spent.

Pricing was reviewed and each category of processing was given to the processor with the best over-all pricing.

**SIGNIFICANT ISSUES:**

Commodity Processing for the 2012-13 year must be approved by the end of February 2012.

The best overall pricing was submitted as follows;

Advance/Pierre – Beef, Jennie-O – Turkey, Tyson Food – Chicken, JR Simplot – Potatoes, Schwan's - Mozzarella Cheese, Land O'Lakes – Barrel Cheese and Wawona - Fruit.

**FISCAL IMPLICATIONS:**

Costs will be borne by the Child Nutrition Budget.

**BENEFIT OF ACTION:**

Passage will allow the district to process the commodities it receives.

**SUPERINTENDENT'S RECOMMENDATION:**

It is recommended that commodity processing be awarded for the 2012-13 school year to Advance/Pierre Foods for Beef, Jennie-O Turkey Sales for Turkey, Tyson Foods for Chicken, J. R. Simplot for Potatoes, Schwan's for Mozzarella Cheese, Land O'Lakes for Barrel Cheese and Wawona for Fruit.
