The school itself sits on land that would have been blasted in the past and the well would have to be placed up the hill beyond that fracture zone. This will require building a path for the well driller.

The water would be used for the school and two school district housing units. Water would be available to the community when many sources freeze up during the winter and when most run out of water during the summer during periods of minimal precipitation. The water would be treated and be vastly safer for consumption than current water sources at the school or community.

We have only tried a shipping container at one site for growing mushrooms. Success at other schools with aquaponic gardening in a shipping container is encouraging for sites where no other means would work. Hyder is on the road system making delivery a reasonable expense.

Our strength has been getting the greenhouses up and working with wood-fired boiler heat. The Hyder school does not and will not get such a unit. Their strength is very low electrical rates of the Canadian electrical grid. This makes it possible to managed a closed system with economical heating and lighting costs that could never be done with an open air greenhouse.

The primary cost will be an electrical contractor. We will use our highly qualified in house staff to install the aquaponic system, ventilation, and humidity controls.

The only option is tapping into the excess heat from the school generator. This is only possible when buying a generator with the capacity to transfer that heat.
