Taylor,

Please allow this as Taylorville Community Credit Union's (TCCU) commitment to purchase 80 new track hurdles for the Pana High School track. It is TCCU's understanding that the cost of the 80 new hurdles will cost \$10,000 along with estimated shipping of \$995. In return, TCCU will require a minimum 4' x 8' sign being placed in a highly visible spot mutually agreeable to the Pana School District and TCCU. Said sign will need to be on year-round display for a period of no less than 60 months. TCCU further agrees to purchase appropriate signage.

At this point, TCCU is ready to cut the check for the new hurdles and shipping when the above conditions are agreed upon by the Pana School District and TCCU. Please let me know if you should have any questions.
