- B. Election Update: Supt. Glaes reported that Margaret O'Brien's position is being challenged and there will be a recount. Mr. Glaes recognized Wil Emmert, David Schriemer for being reelected for another six year term. Deborah Harsha will be replacing Tom Danielson, who chose not to run for re-election.
- C. Important Dates: Mr. Glaes referred to important dates including movie night, the HS play, Holiday parade, and Holiday concerts.

II. REPORTS AND PUBLIC INQUIRY

- A. Food Service Annual Report Maureen Ouvry, Director: Mrs. Ouvry gave her annual report stating that over 300,000 meals were served. HS Kitchen Manager Leslie Tuttle spoke to changes in smart foods at the high school. Compliance with federal Healthy Hunger Free requirements has negatively impacted participation. MS Kitchen Manager Brenda Eberstein talked about Second Chance Breakfast, which is breakfast served on carts in the halls between morning classes. Mrs. Ouvry reported that 100% of her staff participate in the Proud to Learn and Earn Professional Development Program.
- B. Business & Finance Report Steve Goss
 - 1. Monthly Report for October, 2014: Asst. Supt. Goss reviewed the budget progress report for October, 2014 showing total revenues of \$3,509,709; total expenditures of \$5,789,297; and deficiency of revenues over expenditures of -\$2,279,928.

- 2. Bond Update: Mr. Goss gave a status report on construction projects which includes roofs and improved parking lot flow at all buildings.
- 3. 2013-2014 Audit Report: Mr. Goss stated that the District received an Unmodified Opinion which is the highest level of auditor assurance with no audit adjustments or proposed adjustments. The budget was reviewed at a high level of detail.
- 4. Proposed Refunding of 2005 Bonds: Mr. Goss requested authorization as the first step toward refinancing the District's 2005 stadium bonds. Because these bonds are paid with the general resources of the school district and not a voter-approved tax levy, all savings generated by a lower interest rate will benefit the District's general fund.
- C. Tobey PTO: Mr. Barwegen reported that the Tobey PTO holds many activities including the annual pumpkin fest, Little Pizza's fund raiser, and t-shirt sales. Ms. Hawkins and Ms. Schiedel were both present.
