Treasury yields sold-off in June and July, but rallied in August to finish the threemonth period higher by 10 to 15 basis points. As promised, the Fed increased the target Fed funds rate by 25 basis points at the June 13 FOMC meeting.

The summary of economic projections released at the June meeting received the one-dot shift needed to move the median to four hikes in 2018. The FOMC left the target interest rate unchanged at the August I FOMC meeting.

The announcement in August provided no material change in guidance about the expected pace of rate hikes. Second quarter GDP was revised modestly higher to 4.2% for the strongest quarterly growth in nearly four years.

The Fed funds futures market is currently pricing in nearly a 100% probability of a rate hike at the September FOMC meeting and approximately a 65% probability of an additional 25 basis point rate hike at the December meeting.
