## I. SUPERINTENDENT'S REPORT

## A. Recognitions

- South County Services Partnership Award: Danna Downing and Jackie Skinner from South County Services, along with Sherri Louis and Ginger Hill from Generous Hands attended the meeting to congratulate Vicksburg Community Schools for receiving the South County Services Partnership Award. Mrs. Louis thanked the schools for assistance with Generous Hands.
- 2. Excellence in Special Education Award Jeanine Mattson-Gearhart: Mrs. Mattson-Gearhart recognized Amy Stauffer and Zachary Wierenga for receiving the Excellence in Special Education Award.
- 3. 2015-2016 EFE Outstanding Seniors Keevin O'Neill: Mr. O'Neill recognized 14 students being top in their area of focus for Education for Employment.
- B. Legislative Update: Supt. Glaes reported that Governor's budget will be settled after the Revenue Consensus Conference will be held next week.

## II. REPORTS AND PUBLIC INQUIRY

- A. Business and Finance Report Steve Goss
  - 1. Budget Progress Report for the Month Ending April 30, 2016: Asst. Supt. Goss reviewed the budget progress report for April, 2016 showing total revenues of \$ 17,733,460; total expenditures of \$ 17,921,034; and deficiency of revenues over expenditures of -\$ 187,574.
  - 2. Request for Approval to Set June 13, 2016 for the Annual Public Hearing to Consider the District's Proposed 2016-2017 Budget: Mr. Goss stated that the Annual Public Hearing to review the District's proposed 2016-2017 budget will be held at the June 13 Board Meeting. Mr. Goss will also present an

amendment to the 2015-16 budget at that time.

- 3. Kalamazoo Regional Education Service Agency (ISD) General Fund Operating Budget: Asst. Supt. Goss presented highlights to the KRESA budget including an increase of 2.5% to revenues and expenditures for a balanced budget. Mr. Goss recommended that the Board pass the KRESA Budget Resolution later on the agenda.
- 4. Bond Update: Asst. Supt. Goss reported excellent results at the bond sale with nine bidders. Mr. Goss stated that the bid was awarded to Chemical Financial Corporation with an interest rate of 1.69%.
- B. Instructional Report Gail Van Daff
  - Eureka Math Teacher's Guides and Student Materials: Mrs. Van Daff and Mr. VanDussen reported that this proposal is an extension of a proposal approved in 2014. The program is on-line so the only cost to the district is copy and binding costs. The proposal comes to the Board with the support of Middle School Math Teachers, Secondary Math Team, and the Administration.
  - 2. ReadyGen 2016 Proposal: Stephanie Mallery. Mrs. Mallery gave a presentation to the Board for ReadyGen, which is an integrated reading/writing ELA program aimed at K-5 students beginning in the fall.
