## AGREEMENT TO PROVIDE SERVICES/ MOA

The University of Alaska Anchorage (UAA) and Metlakatla School District agree as follows:

1. Scope of Work: Annette Island School District contracts with UAA to:

A. Implement PC-CARES training in Metlakatla.

i. Date(s): 4/10/25 to 4/11/25

ii. Location: 4 Milton St, Metlakatla, AK 99926

2. Agreement Term: The term of this Agreement is April 10 through April 11, 2025. The parties may agree to extend the Term of the Agreement if necessary to complete the work described in Paragraph 1. The parties also agree that they may terminate the Agreement before the end of the Term as provided in Paragraph 10.

3. Compensation: The parties agree that Annette Island School District will pay UAA at an hourly, Instruction rate of \$74 per hour not to exceed \$5,066. total for the work described in Paragraph 1. Annette Island School District agrees to pay all invoices for this work from UAA within 30 days of receipt.

4. Indemnification; To the fullest extent permitted by applicable law Annette Island School District shall defend, indemnify, and hold harmless UAA, its Board of Regents, agents, officers, and employees from or against any and all loss, expense, damage, claim, demand, judgment, fine, charge, lien, liability, action, cause of action, or proceeding of any kind whatsoever (whether arising on account of damages to or loss of property, personal injury, emotional distress, or death) arising directly or indirectly in connection with the advice given by, the products supplied by, or the performance of or activities of the University, its Board of Regents, agents, officers, and employees whether the same arises before or after completion of the University's performance or the termination or expiration of this Agreement, except for damages, loss, or injury resulting from the University's recklessness or intentional acts.

5. Venue and Applicable Law: Any civil action arising from this Agreement shall be brought in the state courts of Alaska in Anchorage, Alaska. The laws of the State of Alaska shall govern the rights and duties of the parties under this agreement.

6. Disclaimer of Warranties: To the fullest extent permitted by law, UAA makes no warranties, express or implied, as to any matter whatsoever including, without limitation, the condition of any work performed under this Agreement, or the merchantability or fitness for a particular

purpose or function of any advice given or of any product prepared, made or developed under this Agreement. Annette Island School District understands and accepts that all UAA's work, products and advice are delivered "As Is" and without warranty.

**7. Assignment:** This Agreement shall not be assigned by either party without the prior written consent of the other.

**8. Termination of Agreement:** Either party may terminate this Agreement with or without cause upon 30 days written notice. In the event of termination Annette Island School District shall pay UAA for its services rendered to the date of termination.

**9. Entire Agreement:** This Agreement is the entire Agreement between the parties and it supersedes all prior agreements, discussions or understandings, written or oral.

**10. Modifications:** The parties may modify or amend this Agreement only in a document signed by the authorized representatives of both parties.

**11. Confidentiality;** Except as required by applicable law or by any court order, UAA agrees to treat information clearly marked as confidential by Annette Island School District in a confidential manner. This means that UAA will use it and distribute it only as necessary to fulfill its obligations under this Agreement. The parties understand, however, that this Paragraph does not prohibit UAA from copying, distributing and using the materials it develops or prepares under this Agreement as provided under Paragraph 9.
