### **SUPERINTENDENT UPDATE:**

Mr. Cruse shared with the Board that three FFA teams have advanced to area Leadership Contest. Twenty Band students were selected for all District Band. # Campus Report

Dr. Colleen Netterville, Principal at Woodland Elementary updated the Board on activities at Woodland Elementary. There has been a huge number of Dads signing up to volunteer in a myriad of ways that serve our children due to the Watch D.O.G.S. program.

Every six weeks Woodland has competitions among their teams to see which team has the highest attendance percentage for that period. The team with the best attendance percentage receives a reward. This six weeks it will be popcorn and a movie in the cafeteria.

An enrichment time has been implemented every day for students not receiving response to intervention. The students spend six weeks working on a project based learning activity that integrates reading, writing, math, research and technology. This arrangement allows the more struggling learners to be served while at the same time providing enriching activities for all other students.
