Dallas was the #7 ranked Best Performing City in the U.S. for 2013 according to the Miliken Institute's annual publication. DFW builders put up 21,236 new homes in 2013, a 19% increase over 2012. 2013 starts are above 1,300 for the first time since 2008, up 32% over 2012. Closings for 2013 are up 30% over 2012, the highest in 4 years.
