	Summary: According to Texas Education Code, Section 44.008 "The board of school trustees of each school district shall have its school district fiscal accounts audited annually at district expense by a certified or public accountant holding a permit from the Texas State Board of Public Accountancy. The audit must be completed following the close of each fiscal year."
	In 2021, the district issued a request for qualifications to hire an external auditor to audit the district's financial accounts. After reviewing the submitted proposals, Armstrong, Vaughan & Associates, was selected by the Board of Trustees to perform the district audit for the fiscal year ending 2021 and 2022 District personnel have been pleased with the work done by the audit team in the last two years Attached is the engagement letter that needs to be signed and returned to the auditor to confirm services for the fiscal year ending 2023.
