





Historical Math Achievement Data




Deep Dive: Reading

Overall proficiency rate is 26.36%, a 8.07 percentage decrease from the previous year

The proficiency rate, of students who took the MCAs is 46.03%, a 0.38 percentage increase from the previous year

Achievement Comparison from 2024 to 2025




Deep Dive: Math

Overall proficiency rate is 12.93%, a 5.51 percentage decrease from the previous year

The proficiency rate, of students who took the MCAs is 23.25%, a 1.19 percentage decrease from the previous year
