Dear Mr. Francis:

Two bids were received on April 16, 2019 for Bid Package T16 which includes a new district-wide firewall solution. In addition to contacting known interested bidders, bids were advertised on the state bid website, Livonia Public Schools website, and in the local paper. Bids were received and publicly opened on April 16, 2019.

Bid Evaluation Summary and Recommendations

After an extensive review of the bid proposals and demonstrations of the products proposed by the low bidder, a thorough post-bid interview was held with the low bidder to verify the proposal was inclusive of the scope of work, and gather information on related experience. The attached Bid Tabulation indicates the bids received, company name, base bid, and alternates.

The voluntary alternates were narrowed down to 3 options that were considered by the evaluation team. Since this project is slightly over budget, the options helped the district consider priorities. Based upon the evaluation of the project team of Barton Malow and Livonia Public Schools technology staff, we recommend that a contract be awarded to the following company based on Option 2 (the 3 options considered are listed on the next page).

Project Cost Review

Because there are a myriad of firewall solutions with varying price points, the RFP was structured for bidders to present multiple options allowing Livonia Public Schools to select the best long-term solution balancing budget and functionality. All three of the options stated below would be appropriately scaled for the district; however, Option 2 provides two redundant firewall appliances for reliability and security. If the first appliance has a hardware failure, connectivity would failover to the redundant appliance and maintain secure district Internet access which is critical to instruction and district business operations.
