# THREE RIVERS SCHOOL DISTRICT BOARD OF DIRECTORS REGULAR MEETING March 13, 2019

#### CALL TO ORDER/EXECUTIVE SESSION

Board Chair Dwyer called the meeting to order at 5:30 p.m. in Executive Session under ORS 192.660(2)(i) – Superintendent Evaluation.

Ms. Dwyer recessed Executive Session at 6:00 p.m.

# **REGULAR SESSION**

The board reconvened in Open Session at 6:05 p.m. and Ms. Dwyer led the audience in the Pledge of Allegiance.

### **AGENDA APPROVAL**

Mr. Halsted made a motion to approve the agenda as presented. Ms. Johnstun seconded the motion; the motion passed unanimously (Members York and Kelly absent).

#### **SAY SOMETHING POSITIVE**

Director Allen-Hart gave a nod out to the special education staff at Evergreen. It has been a busy year. We have a brand-new special ed teacher Emma Portash, who is also working on her special ed endorsement at SOU concurrently and is working really hard! Thanks also to Amy – previously both of them were educational assistants in our Lifeskills program. Director Durrant shared that the district recently had the Oregon Battle of the Books competition. It was held this year at Lorna Byrne. There were 12 elementary school teams and five middle school teams. She thanked all of the people involved that made it such a success! Mr. Halsted thanked Evergreen for hosting the board meeting. He then recognized the bus drivers. They all wave and they all seem happy. He appreciates the positive attitude that they display. Ms. Dwyer commended Evergreen school on their commitment to community collaboration. Every month they host the Caring Community Collaborative, really demonstrating their commitment to the kindergarten readiness begins preconception. They keep the community informed and aware of services and activities.

Ms. Johnstun commented on the *Summary of Grants and Donations Awarded to Three Rivers* in the board packet. It equals \$5.8 million that the district has received. It shows a community that is really supportive of our schools, but also recognizing school administration that have applied for funding for our district that helps us enrich the services that we are able to offer. Superintendent Valenzuela gave a shout out to Illinois Valley High School. They had their local Academic Masters competition today. The whole student body came out to watch and support the participants.

#### SUPERINTENDENT'S REPORT

- SOESD Budget Committee There is an open slot for our area. You have until April 5<sup>th</sup> to fill out an application to become a part of that Budget Committee. There is only one meeting to attend on Friday, May 8<sup>th</sup>.
- Southern Oregon Headstart Lease We are working with Southern Oregon Headstart to renew their lease for the Lorna Byrne facility. This is another example of a great community partnership that we have.
- District Engagement Protocol (DEP) Today TRSD was engaged in a DEP. We hosted four folks from ODE. From the state report cards, we learned that we had five schools that were targeted for some kind of performance issue. He explained the process of identifying the areas and a plan to fix the issue. They will come back and give us an overview and provide us with a direction to go. Once there we have an approved plan, we will be able to access the dollars.
- State School Fund He shared the customized poster that was provided by COSA to push for adequate funding for education in the state of Oregon. This poster talks about a \$9.24 billion budget for education, which would be the base. He encouraged everyone to advocate with our local representatives. Right now the budgets are totally in flux. Last Thursday the co-chairs of the Ways and Means Committee, their budget was at \$8.7 billion. Because of active lobbying from folks like us, and COSA, and OSBA that went up to \$8.8 billion. That is still nowhere close to what we need.

- Kim DeForest, Lincoln Savage MS Teacher Thanked the district for putting out the Budget Survey, which included all of our stakeholders in the district. Class size is a concern. Would like to continue talks about possible ways to think outside the box.
- Ashley Boyce, Josephine County Food Bank/Selma Food Pantry Wants to learn more about what is going on with the Selma Center. She needs a home for the pantry as well as food storage. She is aware the Selma lease is up in June and looking for options.
- Meadow Martell Introduced herself as the Mayor of Cave Junction. She thanked the School Board for coming to Cave Junction.

# Food Service Update

Accounting Manager Lisa Cross updated the board on the financials for the district's food service program. She had emailed a five-year summary to the board. Her year-end estimates differ a bit from John Stone, but they still plan to be in the black at the end of this year. She reminded the board that one full day of closure equals \$11,000 and makes a big difference. She also explained the vended meals revenue decline due to the Boys and Girls Club closure.

#### SUGGESTED FUTURE AGENDA ITEMS

Ms. Johnstun suggested that after they have heard from students at all three high schools it
might be useful to talk through and digest what they have heard from the students and how
that might contribute to their strategic plan. It was decided that this would be a board retreat
topic.
