- 1. Call Meeting to Order: Chairman Christensen called the board meeting to order at 6:39 p.m. with Vice-Chairman Erickson, Trustee Lau, and Trustee Torgesen in attendance.  - **3.1 Approve the Minutes of May 18th, 2016 Board Meeting:** Trustee Lau had previously given Clerk Balls several grammatical and sentence structure suggestions to make the minutes read more clearly. - **9.2 Student Handbooks:** The board reviewed the Thirkill, Tigert Middle School, and High School handbooks for the 2016-2017 school year. During the discussion, it was identified that more information on bullying should be put in each of the handbooks. The principals will add the same verbiage to each handbook. After the discussion, Trustee Lau made a motion to approve the student handbooks as first reading. The motion was seconded by Vice-Chairman Erickson. By a voice vote, the motion passed unanimously.
- **9.3** 1st Reading Policy 578 "Student Participants in Drug Testing": There were some wording changes to make the policy read simpler. After the discussion, Vice-Chairman Erickson made a motion to accept Policy 578 as 1st reading. The motion was seconded by Trustee Lau. By a voice vote, the motion passed unanimously.
- **10. Facilities:** A lengthy discussion was had regarding school facilities, input from the public, and the current needs of each building. After reviewing the current need and public input data indicating 51.61% support, it was determined to move forth with pursing the Tigert Middle School proposal of constructing a new gym, replacing the existing annex buildings, and creating a secure entrance. The board elected to seek school patron approval for the bonding of this project during the November Election.
