**Regular Board of Education Meeting
December 15, 2025 – 6:00 p.m.**

1. Call to Order

President Burns called the meeting to order at 6:00 p.m. on December 15, 2025, at 1300 S. 109th Street, West Allis.

6. Hoover Elementary School Student Showcase

Hoover Elementary School Principal Vang briefly reviewed the District's Theory of Action and how it connects to the learning that the students will be sharing. Third grade teacher Ms. Supple introduced students Zoey, Audrina, Dallas, and Kallie who discussed their podcast. Ms. Supple and the students detailed how guests are chosen for podcasts, student roles for the podcast, and the soft skills students gain from this experience. WAWM Pipeline for Interns & Student Teachers:

D. Garcia, Director of Talent Acquisition & Employee Engagement, gave an update on the talent pipeline for interns and student teachers, which includes opportunities for full-time employment, as well as discussed improved vacancy rates. Lisa Erickson, a veteran teacher with 31 years of service within the district and Emma Seymer, intern, also discussed how intern and student teacher opportunities have benefited students as well as enhanced their own skills.

Student Advisory Committee - The Voice:

Dr. Robinson introduced the Student Advisory Committee - The Voice representative Victoria (Vic) Sundquist. Ms. Sundquist is a junior at Dottke, dual-enrolled at Nathan Hale, a volunteer with the Nathan Hale football team and other sports, previously worked with the Youth Commission and Mayor, helped with Dottke's library over the summer and was part of the crew that made it possible, and also a member of Rotary. Ms. Sundquist shared that Dottke recently held two 8th-grade Discovery Nights, resulting in 45 students signing up to attend next year. Dottke is also preparing for its January 26th Exhibition Night and (this week) is hosting Spirit Week, a Winter Festival on the 19th, a student leadership conference for an English class, and the conclusion of the December attendance challenge.

President Burns opened the floor for public comments at 6:55 p.m., allowing district residents up to three minutes each to speak in person or via Zoom, and provided instructions for participation. President Burns noted that the Board could not discuss, debate, or act on any items raised, and that the Superintendent may provide follow-up at the next regular Board meeting. 9.2.1 Employee Engagement & Culture – Carr

Committee Chair Carr reported that the committee met on December 11, 2025. The committee reviewed updated staff survey results from School Perceptions and agreed to focus on four Net Promoter Scores that align with the district's strategic plan. Future work will include revising KPIs to center on these scores, transitioning away from a standalone survey participation KPI, and emphasizing cross-department collaboration to support professional learning, retention, and overall staff experience. The committee also discussed challenges with special education vacancies, offered support, raised questions for Cabinet, and requested finalized district KPIs for the next meeting.

9.3 Board Member Reports of Community Events:

- Ms. Deal attended the Zeman Family Foundation's annual Target shopping event, where alumnus Greg Zeman's foundation provided elementary students with \$100 each to shop for holiday gifts. The event was supported by staff and 200 high school volunteers, creating a joyful and meaningful community experience for families. A special thank you to the Zeman Family Foundation for their ongoing support and Shelly Strasser and her team for organizing the event.
- Mr. Keller shared appreciation for the Zeman Family Foundation event, highlighting the gratitude of families, the strong turnout of staff, athletes, and coaches, and giving special thanks to Target and Starbucks for opening early to support.
- President Burns attended Hoover's winter choir concert, which featured both choral performances and an engaging recorder jam session.
