You are hereby notified that at the regular meeting of the School Board of Independent School District No. 877 held on April 26, 2021, consideration was given to your placement on unrequested leave of absence without pay or fringe benefits from your position as a World Cultures teacher of Independent School District No. 877, and a resolution (copy enclosed) was adopted by a majority vote of the Board, proposing your placement on unrequested leave of absence effective at the end of the 2020-21 school year on June 30, 2021, pursuant to Minnesota Statutes 122A.40, subdivision 10, along with applicable provisions of ARTICLE VI, Section 3, Subdivisions 1-6 of the current Master Agreement between the School District and the exclusive representative. The grounds for your placement on an unrequested leave of absence are: financial limitations and discontinuance of your World Cultures position.

Your proposed placement on unrequested leave of absence is not the result of the implementation of an education district agreement.
