# **Financial Report by Cindy Duley**

New report format as requested, showing all payments made for projects since inception starting July 2021, through June 30, 2023.

Expected and saw spending ramp up June/July, to continue August/September. Two OSCIM claims outstanding; \$10,782 balance on the grant claim including most recent Claim #8 for \$603,299 incurred since June 30.

\$3.8M project funds remaining.

Tamie asked Derek about remaining project costs. Derek expects \$3.3M remaining for Bremik commitment. \$500k left for other projects. Costs of those need to be scoped out. Have remaining projects been prioritized? Not yet. Any recall of the original estimates? To be determined.

When we looked at projections before, there was a cost overage.

At next meeting, present remaining budget categories, want to know if we have sufficient funds for plans. Will be closer to finished with Bremik. Request for updated project spreadsheet prior to next meeting.

Michelle question about Steve Gunn expenses. Carson will check.

Any additional comments? Derek expects to start students and staff in the new building on Jan 8. There was a group tour of the Woodard property prior to the meeting tonight.
