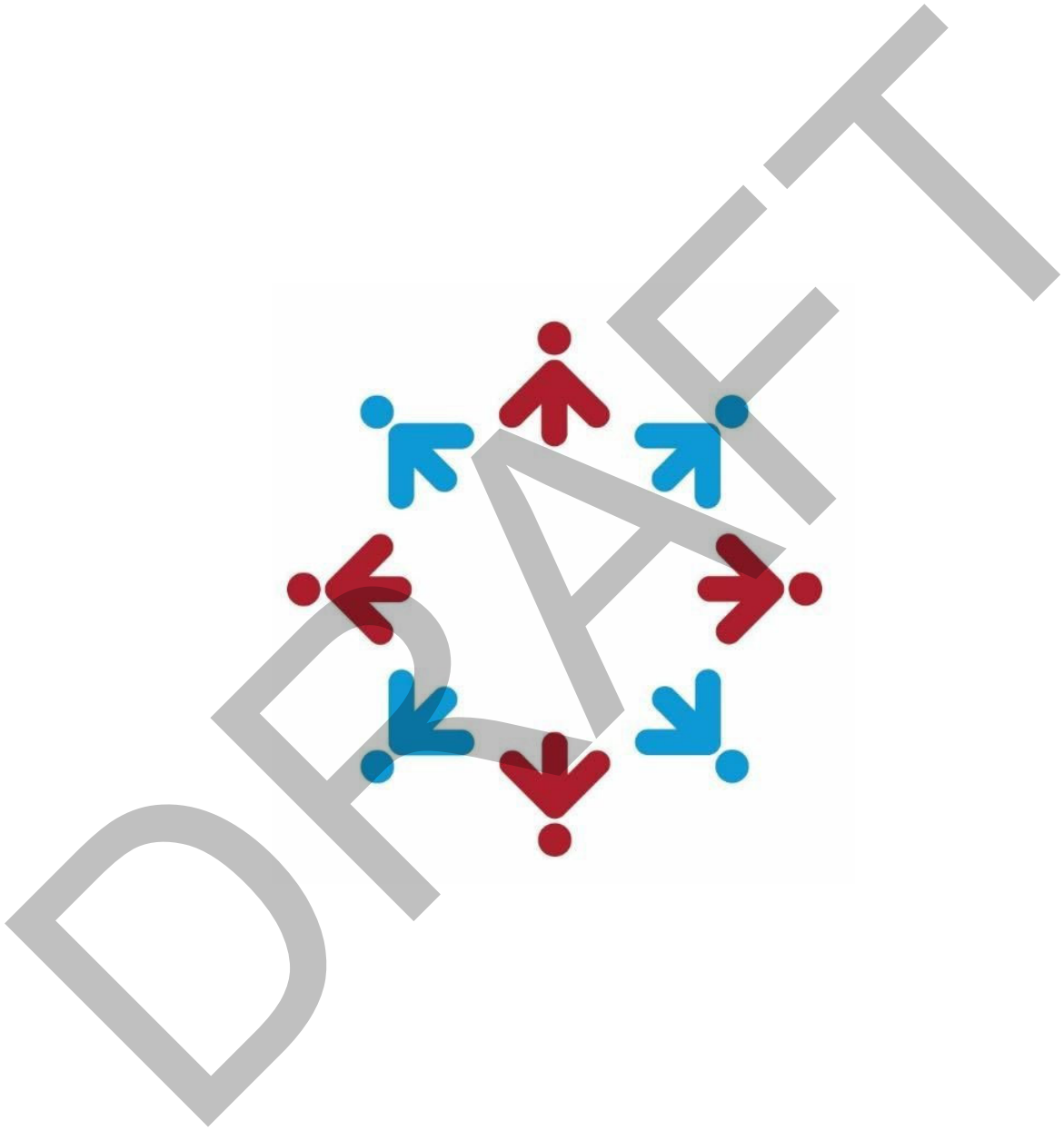
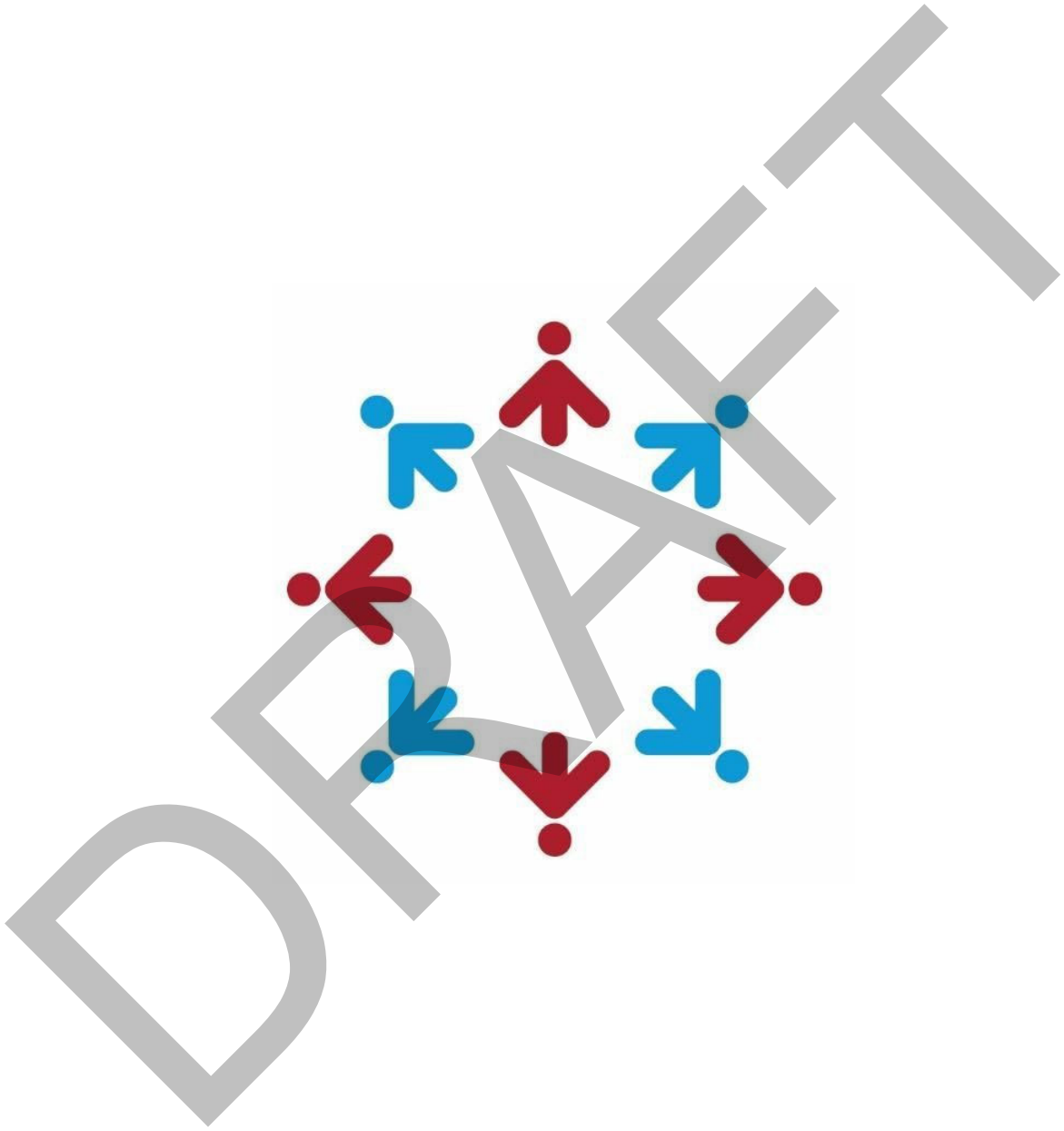

INTRODUCTION

Pursuant to the Minnesota Statute 123B.77, we are pleased to submit the District's FY27 Budget for your review and approval.

This preliminary budget has been developed with input from the District's members of the Superintendent's Cabinet and the District's learning leaders. This budget seeks to continue to support the District's mission of partnership with families and community to provide educational opportunities to ensure academic, social, civic, and personal readiness for every student, while keeping expenditures and taxpayer burden to a minimum.

This budget has been designed to give readers a better understanding of the financial structure and budgeting process of the District. All budgets have been organized using a pyramid approach so readers may progress from an overview to greater levels of detail (macro to micro). This approach starts with a summary of all fund categories and then presents individual funds. Readers are able to work their way "down" the pyramid and budget details become more specific as they move from the beginning to the end of the document.

REPORTING ENTITY AND ITS SERVICES

The District is an instrument of the State of Minnesota, established to function as an educational institution. The District is a fiscally independent entity that has the exclusive responsibility and accountability for the decisions it makes. It has statutory authority to adopt its own budget, levy taxes, and issue bonded debt without the approval of another government. A Superintendent is appointed by the School Board and is responsible for administrative control of the District.

The District is an award-winning school district in the southern Twin Cities Metropolitan Area. The District serves a projected 12,104 students in Dakota and Scott counties covering 86 square miles, including most of Lakeville, parts of Burnsville, Credit River, Elko New Market, and portions of Eureka, New Market, and Spring Lake townships.

The District is organized by elementary schools serving students in kindergarten through grade 5, middle schools serving grades 6-8, and the high schools serving grades 9-12. The District operates 17 educational facilities: 2 high schools, an alternative learning center, 3 middle schools, 9 elementary schools, 1 early education program and Community Education, as well as 1 online program, Lakeville Online Academy.

REPORT FORMAT

The budget document is presented in three parts:

1. **Introductory Section:** Contains this transmittal letter, the list of School Board members and the Superintendent's Executive Cabinet members.
2. **Financial Section:** Organized into four levels using a pyramid approach to provide further detailed levels. The four levels are as follows:
 - i. Level One – Summary of All Funds
 - ii. Level Two – Summary of General Fund
 - iii. Level Three – Summary of Individual Funds Special
 - iv. Level Four – Summary of School Expenditures by Site
3. **Informational Section:** Provides selected financial, demographic, and economic data in the Appendix.

FINANCIAL AND BUDGETARY CONTROL

The management of the District is responsible for establishing and maintaining internal controls designed to ensure that they are protected from theft, misuse or losses.

The internal control system is designed to provide reasonable, but not absolute, assurance that these objectives are met. The concept of reasonable assurance recognizes that: 1) the cost of a control should not exceed the benefits likely to be derived, and 2) the valuation of the costs and benefits requires estimates and judgments by management.

The District's budget process is based on the development of a budget projection model that attempts to project resources and expenses over a multiple-year period. The budget projection is used by the School Board and the administration to determine budget parameters and staffing guidelines. This budget has been prepared in accordance with the budget parameters and personnel staffing guidelines approved by the School Board.

Legal budgetary control is at the fund level; however, directors, principals, coordinators and other budget managers are responsible for monitoring their individual budgets within each of the funds. All appropriations lapse at fiscal year-end.

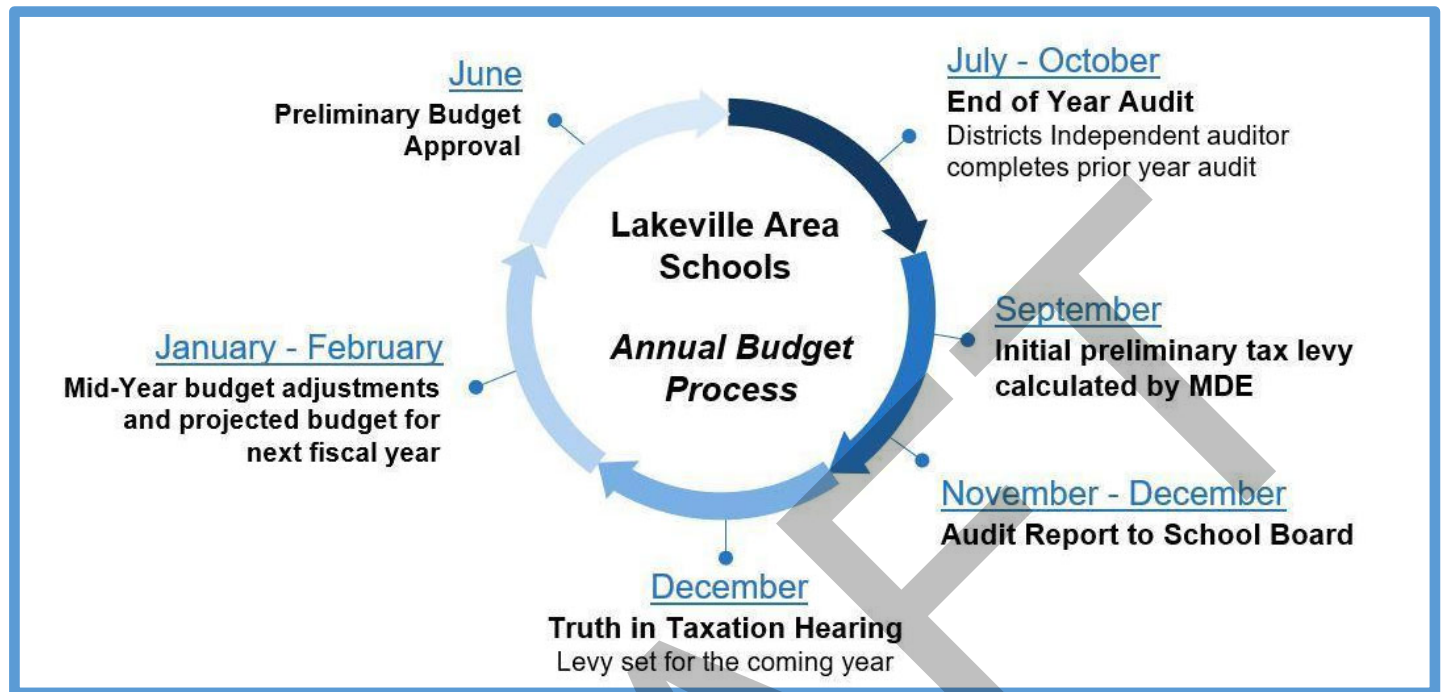

FINANCIAL PROSPECTS FOR FUTURE YEARS

With the exception of the voter-approved operating levies and capital projects levy, the District is dependent on the State of Minnesota for its revenue.

Over the past decade, state funding for education has not kept pace with inflation. Increases to the basic general education formula allowance approved by the Minnesota Legislature has been less than inflation.

This current legislation appropriated a 2.69% increase in general education formula allowance for the FY27 school year. These funding increases from the state along with funds from the operating referendum levies enables the District to maintain quality programs.

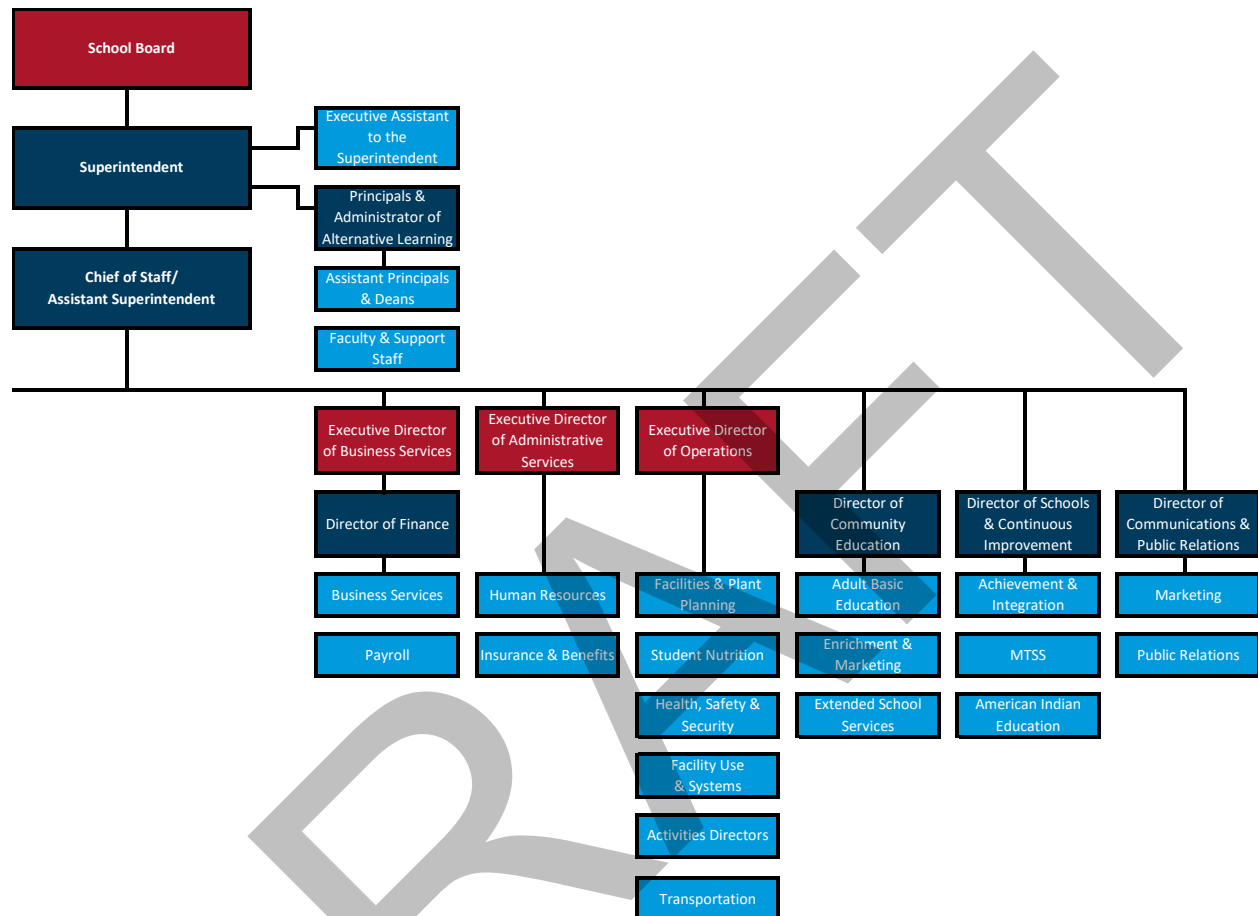

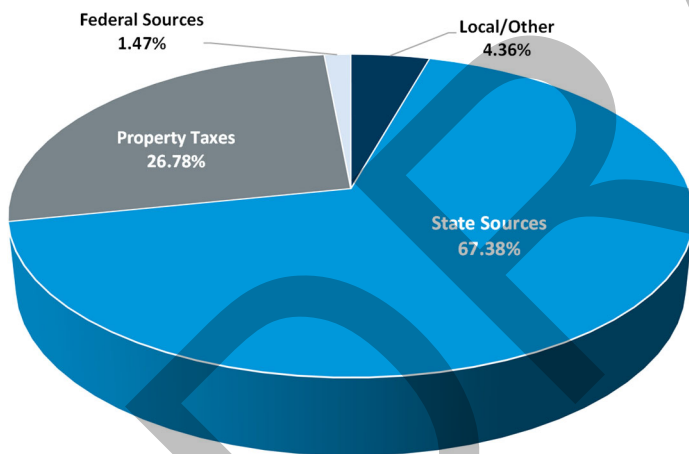

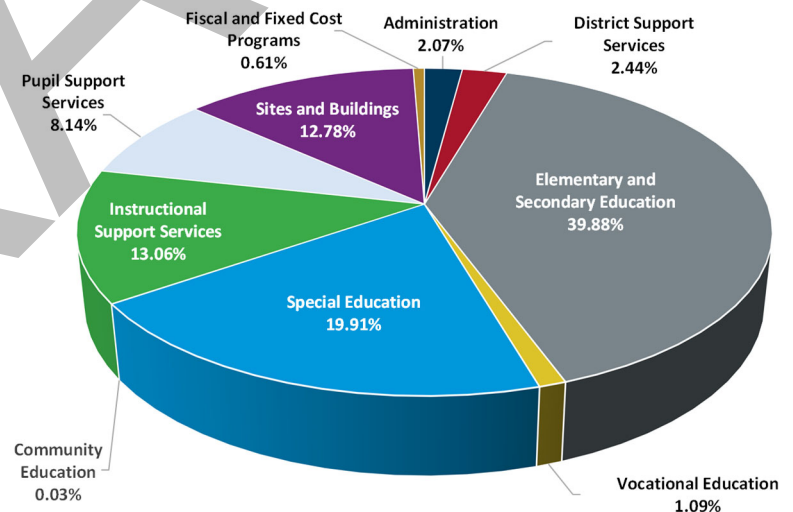

FY27 General Fund Expenditures

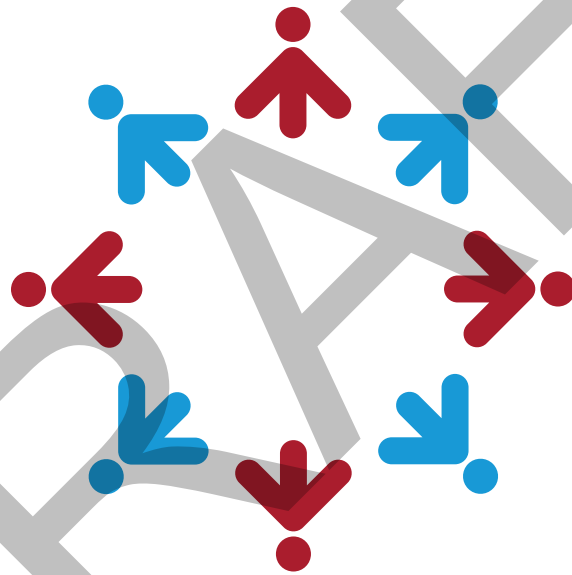

Summary of General Fund



General Fund

Fund Overview – The General Fund is the primary operating fund of the District and accounts for the revenues and expenditures associated with providing a public education to children.

Notable Changes for the FY27 General Fund revenue budget are as follows:

- Total revenue is projected to increase by \$8.8 million. This includes state sources of \$3.9 million and \$4.7 million in tax revenue. Federal sources continue to shrink now to \$3,255,768 and the District local revenue sources are increasing to \$9,638,000.
- The increase in state revenue is generated by a 2.69% increase in the pupil formula allowance by the state legislature and an approximately 0.2% increase in enrollment.
- The Legislature has decreased student support restricted funds by \$169,150.
- The Special Education transportation budget has been decreased by \$400,000 due to legislative action in the 2025 session.

Notable Changes for the FY27 General Fund expenditure budget are as follows:

- Total General Fund expenditures are increasing by 6.26% or \$13.3 million.
- Due to the new READ Act legislation, expenditures in administrative support and staff development have increased.
- Secondary Teaching and Learning are continuing to update curriculum to align with state standards.
- Due to the upcoming refresh cycle on technology devices, a new lease will be issued for all the student devices.
- Minnesota Paid Family & Medical Leave started on January 1, 2026, and is funded by a premium of 0.88% on wages, split equally between the District and the employee. The District's general fund portion for FY27 is \$485,881.

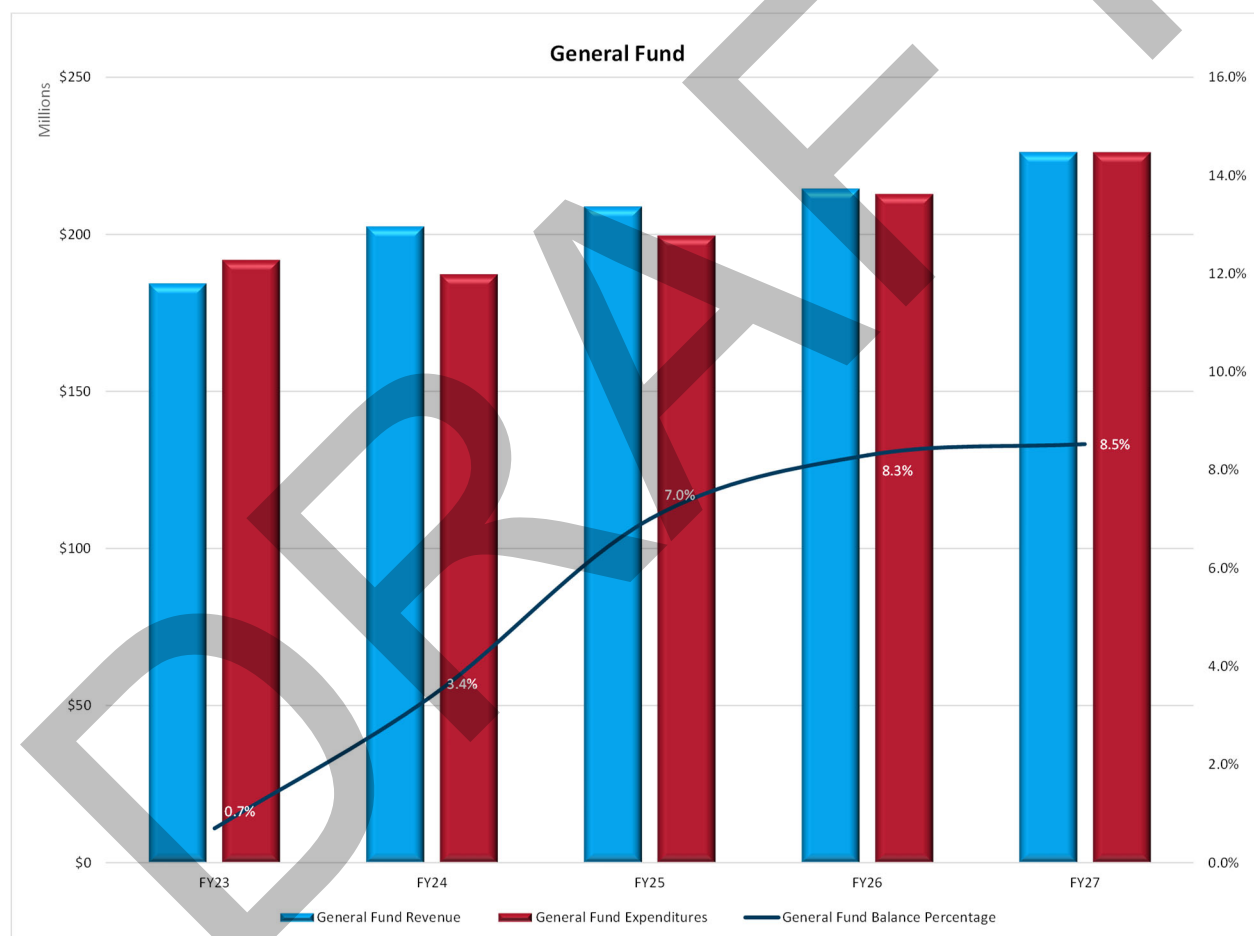

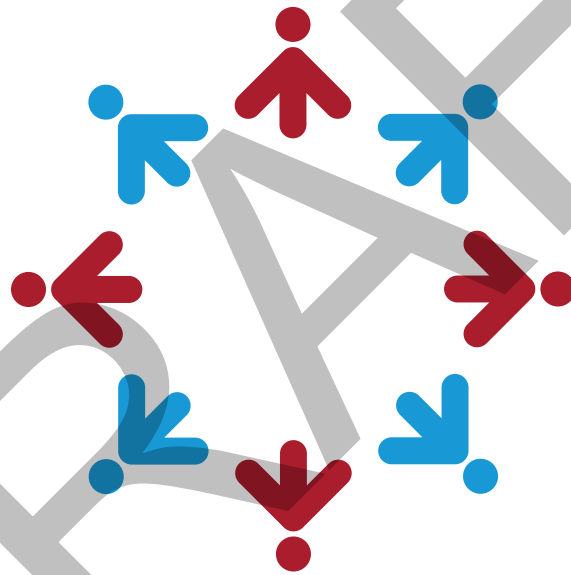

The proposed budget has an excess of revenues over expenditures of approximately \$1.6 million in the unassigned category. The June 30, 2027, unassigned fund balance is estimated to finish the year at approximately 8.5%.

Food Service Fund

Fund Overview – Food Service Special Revenue Fund is used to account for the District’s student nutrition program, which provides high-quality, nutritious breakfasts and lunches for students. The Food Service Special Revenue Fund is self-sustaining. All costs of the food and nutrition programs are covered by receipts from sales to students and adults, and reimbursements from federal and state governments.

Notable changes for the 2026-27 Preliminary Budget include:

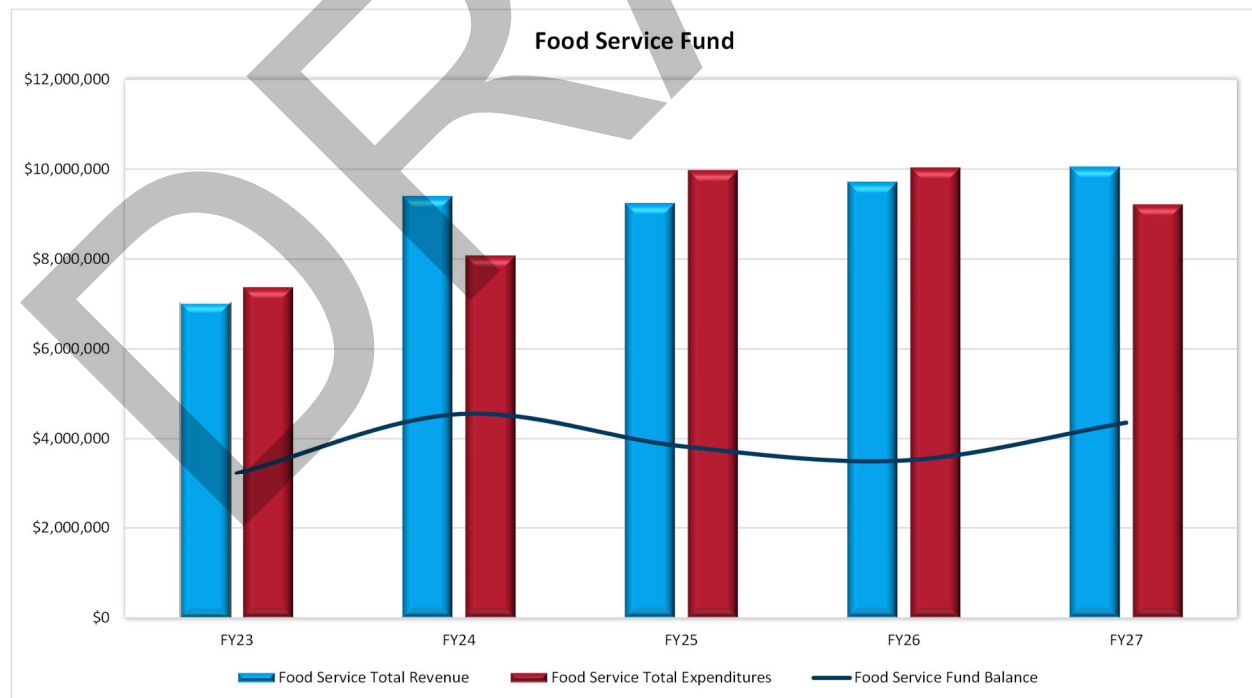
- **Labor & Benefits:** The budget includes a 2% increase in hourly wages for kitchen staff due to cost of living. Health Insurance rates increased significantly, resulting in an increase in health insurance expenses.
- **Equipment needs:** During the 2024-2025 and 2025-2026 school years, we replaced much of our aging kitchen equipment. We have a few older ovens and tilt skillets that we plan to replace in FY27 as well as some older warmers and roll-in oven racks.
- **Food Costs:** Due to the war in the Middle East, fuel and fertilizer prices are anticipated to drive up food prices. We planned for a 5% increase in food costs to account for this anticipated increase.
- **We have assumed the operation of summer meals starting in June 2026 for the Summer Adventures, Wonder Zone, and Den programs.** This will result in an increase in food, milk, supplies, labor, and revenue this summer.
- **Federal Reimbursement Rates:** The White House released the FY 2027 budget blueprint which includes proposed increased funding for the National School Lunch Program and School Breakfast Program to reflect inflation and anticipated participation growth. We budgeted for an increase in reimbursement rates, slightly less than the final reimbursement rates for school year 25-26.
- **We have spent down our fund balance to a balance of 3 to 4 months operating expenses and anticipate ending the current fiscal year within that range.** While the budget for FY27 is projecting an increase to the fund balance, we are planning for a large walk-in cooler and freezer relocation and replacement at Christina Huddleston Elementary in the summer of 2027 in addition to planning for costs associated with the middle school expansions due to the passing of the referendum.

Student Nutrition will continue working on thoughtful and sustainable plans to balance spending while keeping the net cash resource limitation to 3 months average operating expenditures.

Community Service Fund

Fund Overview – The Community Service Special Revenue Fund is used to account for services provided to residents in the areas of recreation, civic activities, nonpublic pupils, adult, and early childhood programs, or other similar services. The Community Service Special Revenue Fund is required to be self-sustaining, in which all fees, sales and other reimbursements are expected to cover the operating costs associated with this fund.

Notable changes for the 2026-27 Preliminary Budget include:

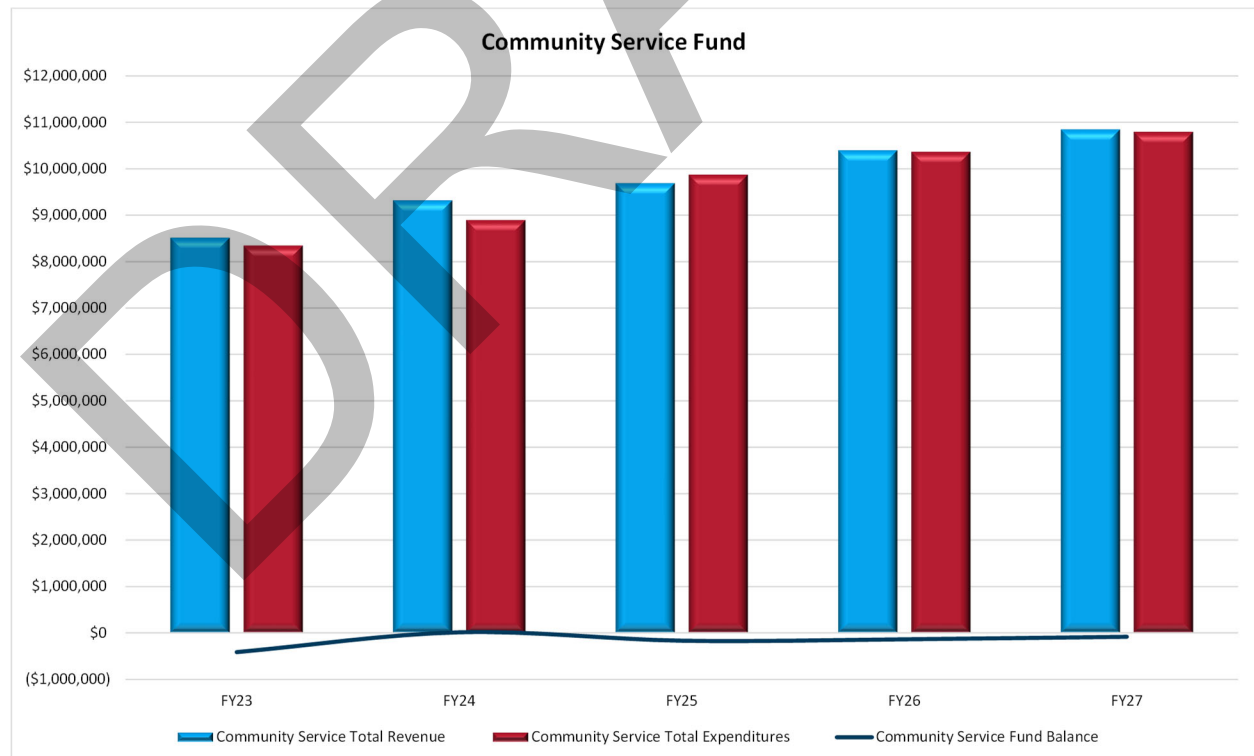
- Adjustments have been made across all programs area budgets in order to reflect changes in programs and services, projected enrollments and costs, adapt to market changes and deliver a positive budget within the 2026-27 fiscal year, however most programs are experiencing strong demand which is reflected in the growth in revenue and related expenses.
- Total revenue is projected to increase by \$451,461, or 4.3%. The Increase includes growth in revenues in the Small Wonders Preschool, Cheerleading, and Aquatics programs. Overall, continued strong demand for programming, as well as increases in fees and tuition have helped raise revenue for fee-based programs.
- Total expenditure is projected to increase by \$427,443, or 4.1%. The increase includes growth in the Small Wonders Preschool staffing, benefits, and supply expense, as well as School-Age Care staff who are specifically dedicated to serving children with special needs. Due to contract changes for Preschool Teachers within the 2025-2027 EML contract, the District has decided to reimburse the Community Education Fund for up to \$100,000 of preschool expenses for the 2026-27 fiscal year.
- Note that the Community Education Department expenditures include an estimated \$190,000 in non-reimbursable expenses related to serving children with special needs in the Wonder Zone preschool-age child care program, and \$177,600 in chargebacks to the District's General Fund.
- Given a projected -\$138,381 starting fund balance, the ending fund balance is projected to improve to -\$84,186 at the end of 2026-27. This amount represents -0.8% of total expenditures.
- The Community Service fund balance is restricted for categorical programs.
- The budget reflects current legislation as of the time of budget preparation.
- Several collective bargaining agreements and individual employment agreements have not been settled for 2026-27 as of the time of budget preparation.
- The revised and preliminary budgets do not reflect potential severance disbursements.

The preliminary budget was shared with the Community Education Advisory Council prior to the May 7, 2026 meeting. During the meeting the Advisory Council had an opportunity to ask questions and provide feedback.

Building Construction Fund

Fund Overview – Up through 2015-16 school year, the Building Construction Fund was used to account for the financial resources used for the acquisition or construction of major capital facilities authorized by bond issue and state-approved alternative facility projects supported by property tax levy. Since July 1, 2016, alternative facility projects are supported by the Long-Term Facility Maintenance (LTFM) Program. The revenues and expenditures for LTFM projects must be reported in the general fund if they are supported by local property taxes and reported in the capital projects building construction fund if they are funded by bond proceeds.

In FY26 the District issued \$20,600,000 in Facilities Maintenance bonds to partially fund the deferred maintenance projects in FY27 and FY28. The District will issue bonds in September 2026 for the new additions planned for the middle schools. The District’s general obligation bond total as of June 30, 2026, is \$165,355,000.

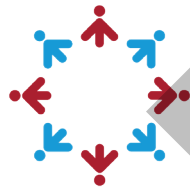
