Swanson moved to amend the proposed draft to revise paragraph 5, line 315 to say "The superintendent or the superintendent's designee shall inform the requestor and the school board of the Review Committee's decision. A requester may appeal the review committee's decision to the school board. Upon appeal, the Review Committee will provide its recommendation to the school board for review and a vote as to how to address the challenged material as to retention, restriction or relocation in the district's library, second by Carbone. Carbone called the question - motion passed unanimously. Vote: 4 Ayes (Thompson, Swanson, Carbone, Reichenberger), 3 nays (Anderson, Baker, Cameron). Motion passed, 4-3. Vote on original motion with amendment from Swanson that was passed. Vote: Ayes 4, nays 0, motion carried, 4-3.
