Application Information

The Oregon Department of Education offers a non-competitive 2012-13 Opportunity Initiative to all current 21st CCLC grantees.

Context: In 2011-12, ODE provided a two-phase STEM initiative. The 1st Phase was a non-competitive supplement (of \$25,000) offered to each grantee to implement quality STEM activities in their afterschool programming. 25 grantees applied and awards were issued to all applicants. The 2nd phase provided an opportunity for all those that applied for the non-competitive funds to apply for competitive STEM Professional Development grants (at \$50,000 each). Five STEM Professional Development grants were awarded.

In September 2012, ODE disseminated a survey to all grantees. Responses expressed strong and diverse interest in all three areas offered in this opportunity: **STEM:** Continuing and strengthening from 2011-12; **EL:** enhancing 21st CCLC EL services; **Sustainability:** developing program sustainability efforts. All three options are included due to these survey responses. Applicants may apply for any of the three.

All <u>Year #4</u> grantees may request 21st CCLC (non-competitive) Opportunity Initiative funds to supplement current programs to enhance one or more of three key areas:

- Science Technology Engineering and Math (STEM)
- English Learners (EL)
- 21st CCLC Program Sustainability

All Year #5 sub-grantees have a similar but simpler (and separate) Opportunity Initiative application, due to the shortened time remaining in their grants.

Which grantees are eligible to apply for the 21st CCLC 2012-13 Opportunity Initiative?

• This application is available to all <u>Year #4</u> Grantees. All current <u>Year #4</u> grantees are invited to submit a proposal for the 2012-13 Opportunity Initiative using these rules.

What must 21st CCLC sub-grantees do to receive this money?

- The 2012-13 21st CCLC Opportunity Initiative requires <u>Year #4</u> sub-grantees to submit a proposal to the ODE on or before January 18, 2013. Each grantee may submit a proposal up to the amount of \$25,000, which, when the application meets requirements, will be awarded as soon as the application is approved by ODE.
- If any funds remain, they will be equally distributed among those sub-grantees that have applied.

How may the 21st CCLC Opportunity Initiative Grant funds be used?

- The 21st CCLC Opportunity Initiative funds may be used to provide training and ongoing support and focus on quality activities and instruction in the three areas identified within the scope of the originally approved grant at the grantees' existing sites.
- The 2012-13 21st CCLC Opportunity Initiative funds are governed by all Title IV-B and EDGAR fiscal regulations, including Supplement/Not Supplant requirements.
- The Oregon Department of Education may require revision of Opportunity Initiative proposals and budgets prior to approval, award, or release of funds. The Oregon Department of Education decisions on funding and awarding grants shall be final.

What limitations apply to the 21st CCLC Opportunity Initiative funds?

The 21st CCLC 2012-13 Opportunity Initiative funds provide resources to support current grantees in three areas:

- **STEM:** increase use of STEM instructional practices that support interconnected, quality and inquiry-based STEM instruction;
- **EL:** enhance partnerships and maximize inclusion of underrepresented populations to improve their success;
- Sustainability: plans & strategies to continue afterschool program services to students, families and communities.

The 21st CCLC 2012-13 Opportunity Initiative funds are governed by all Title IV-B state and federal Education Department Grant Administration Regulations (EDGAR), including Supplement/Not Supplant requirements.
