# 4. UNFINISHED BUSINESS

# 4.1. Approval of Award of the Crisis Alert System to Centegix

Superintendent Bartlett provided requested information related to the financial viability, new contract terms, and legal review of contract language for Centegix to the governing board since the board's prior review on October 4, 2024. The Centegix Safety Platform is the foundation for a layered safety plan, empowering all employees with the fastest response to medical emergencies, student altercations, unauthorized visitors, and suspicious activity. Centegix submitted a 1GPA proposal for contract services, equipment, and materials in the amount of \$484,000.00 and for tax in the amount of approximately \$35,670.00, totaling \$519,670.00. The district negotiated a five-year equal payment plan with the first year's payment to include the installation and set-up, along with the annual subscription fee. The remaining balance would be spread over the next four years of the contract. District administration met with the Chief Financial Officer of Centegix, and contract language was reviewed by the legal team at the Arizona School Risk Retention Trust, Inc., (the Trust). Work will begin in November of 2024 with full implementation expected within three months. The project will be funded partially through bond funds and the remainder from District Additional Assistance. Staff will be required to wear the badge and district human resources policy will be amended to include the new requirement.

Board members thanked the district for their swift action to provide an additional security measure to empower staff and for the hard work involved to negotiate a contract with Centegix that is favorable to the district.

Upon a motion by Gina Mehmert and a second by Carole Siegler, the governing board approved the award of the crisis alert system to Centegix in the amount of \$519,670.00, as presented.

# 5. **NEW BUSINESS**

### 5.1. Approval of the 2025-2026 School Year Calendar

Associate Superintendent Mindy Westover presented for final approval the 2025-2026 school year calendar which was preliminarily approved by the governing board in January 2024. Ms. Westover stated the calendar represents the best balance of calendar preferences and alternatives. 2025-2026 calendar highlights include: new teachers report on Wednesday, July 23, and returning teachers on Tuesday, July 29; the first day of school is Monday, August 4; during the first week of school, elementary schools observe an early release and middle school a late start; the high school starts at 8:35 a.m. and observes a regular day rotating schedule; the last day of school (Wednesday, May 20) is a half day for students and a full day for staff; Fall break is October 6 – 10; K-12 parent/teacher conferences are October 21, 22, and 23, and PreK on September 22 - October 3, and April 20 - May 1 by appointment; Tuesday, November 11 is a student holiday to observe Veteran's Day; the high school observes a short week schedule during the week of Thanksgiving and first semester exams; Winter break includes three weekends; the semesters are evenly divided (90/90 days); and the last contract day for teachers (Thursday, May 21) is a full day.

A board member inquired about the student absenteeism rate during parent teacher conference week in October versus prior school years without a full week for Fall Break. District administration will provide an update to the governing board.

Upon a motion by Carole Siegler and a second by Gina Mehmert, the governing board approved the 2025-2026 school year calendar, as presented.

#### 5.2. Initial Review of the 2026-2027 School Year Calendar

Associate Superintendent Westover presented the preliminary 2026-2027 school calendar. The draft is similar to the 2025-2026 calendar: new teachers report on July 29 and returning teachers on August 4; the first day of school is August 10; Fall Break is October 12 – 16; K-12 parent-teacher conferences are October 27, 28, and 29, and PreK parent-teacher conferences are September 28 – October 9 and April 19 – April 30 by appointment only; Wednesday, November 11 is a student holiday to observe Veteran's Day; Winter Break includes three

weekends; the semesters are unevenly divided 85/95 days; the last day of school is Wednesday, May 26; and the last contract day for teachers is Thursday, May 27.

A board member inquired whether the 85/95 semester split affects high school one semester courses. There are enough instructional minutes in the eighty-five days to meet the state's instructional minute requirement.

A board member asked how the dates for Spring Break are determined. The decision is made due to state testing. In the past, Spring Break was during the first week of April. Administrators found this caused a hindrance to elementary students taking the state writing test on a specific date set by the Arizona Department of Education. Administration discussed moving Spring Break to an earlier week in March similar to other Tucson area school districts and decided not to move due to a longer period without a school break for students and staff.

A second reading of the 2026-2027 calendar is on the agenda for the November 4, 2024, regular governing board meeting.

#### 6. **DISCUSSION / REPORTS**

# 6.1. Annual Bond and Capital Override Report

Superintendent Bartlett updated the governing board and the community about the progress of capital improvements financed through bonds authorized by voters in November 2022 for \$38.5 million. In April 2023, the first issuance of bonds was sold for \$14,956,400. The district expended \$1,260,632 in fiscal year 2023 for design services for the high school strings program addition and design services for security upgrades to all school campuses. In fiscal year 2024, the district expended \$9,998,443.39 for construction/contraction of the high school strings program addition, the security upgrades on all school campuses, and the purchase of new school buses. The balance as of July 1, 2024, was \$3,697,324.61.

Dr. Bartlett also updated the governing board on the annual \$2,000,000 District Additional Assistance override for technology equipment and software, teaching and learning resources, and infrastructure in effect through fiscal year 2029-2030.

Detailed information about expenditures from the <u>Bond and Capital Override Report</u> was made available to the CFSD community as part of the governing board meeting agenda on the CFSD website.

Board members emphasized the importance of the support provided by CFSD constituents who approve bonds and overrides, ensuring the success of our schools. Board members thanked the superintendent and CFSD staff for transparent and sound stewardship of the funds entrusted to the district by the CFSD community. Superintendent Bartlett shared that a second issuance of bonds is projected for April 2024.

### 6.2. Arizona Legislative / Governmental Activity

There was no discussion.

There were no requests for future agenda considerations.
