<b>netFIBER20</b> netFIBER20 is a large-scale, carrier-class network created by the Education Service Center, Region 20 Consortium, allowing member districts to access high-speed, high-bandwidth connectivity services over a brand new dedicated fiber network at a very low cost. The Consortium consists of ESC Region 20, school districts, and public/private charter schools in our region. This collaborative effort has given us a competitive price advantage as well as E-Rate and special construction discounts from the FCC and the TEA. Through netFIBER20, districts can also partner with one another in many different ways, including sharing of services and disaster recovery.	BTS
