CALL TO ORDER

Board Chair Halsted called the meeting to order at: 4:06 PM, requested that Board Member Johnstun lead the meeting as he was virtual, and she led the audience in the Pledge of Allegiance.

Member Camp made a motion to approve the agenda as presented. Member Reese seconded the motion, which passed unanimously (5-0).

SUPERINTENDENT'S REPORT

Superintendent Valenzuela played a video showing the flooding at Fort Vannoy Elementary that occurred on March 17th, 2025. He showed a slide show of the damages, the clean-up efforts, and repairs. He recognized the heroic efforts of the Fort Vannoy staff, the maintenance department, first responders, and Belfor restoration to quickly get students back to school.

The cost for this K-5 ELA adoption cost is approximately \$633,802. There was some discussion regarding the time frame of the last adoption. Vice Chair Kelly inquires if this program was phonics based which Director Durrent verified. Board Chair Halsted makes a motion to approve the adoption. Vice Chair Kelly seconded the motion, all in favor excluding Member Reese who abstained with no reason stated.
