This letter transmits an update from Plante Moran Cresa (PMC) as it relates to the assignment to assist and advise Livonia Public Schools (LPS) in its selection of a Civil Engineer for the Projects listed above. This update represents the mutual efforts of PMC and LPS administration and staff to present a framework in order to identify, evaluate and recommend Firms for this Project.

NTH Consultants and LPS have a longstanding relationship and have been working together for over a decade, which currently includes materials testing services for the bond projects. Earlier this year, NTH was awarded a sinking fund contract to perform pavement replacement work at Hayes Elementary, Kennedy Elementary, and Riley Upper Elementary. PMC and LPS have been satisfied with their work and are recommending they be re-engaged for the 2017 Projects. Attached is a contract amendment for the proposed 2017 work in the amount of \$150,000.00.

For the Civil Engineer, the costs for this work will be detailed in a Purchase Order issued by the District, and in a contract amendment to their original contract, pending final review and approval by district legal counsel.

The Owner and Architect further agree to the Amend the Contract as written below:

The following adjustments shall be made to Compensation and Time for the Architect's Basic Services:

Compensation: A Lump Sum Fee of One Hundred Fifty Thousand Dollars (\$150,000.00). See attached Proposal dated November 4, 2016.

Time: Substantial Completion by August 11, 2017. See attached Milestone Schedule

The Scope of Work shall not include surveying, geo-technical engineering or material testing.

The Architect shall advise the Owner of any adjustments to the preliminary estimate of Construction Cost at the end of the Design Development Phase.

In the event the Cost of the Work is substantially lower than the Design Development Estimate, more than ten percent (10%), the Architect's Fee will be recalculated at 6.8% of the Cost of the Work.

Based on the scope of work associated with the 2017 program under to our established contract with LPS through Plante Moran Cresa, NTH's design fees for the 2017 program would be a lump sum fee of \$150,000. The design fees are approximately 6.8 percent of the construction cost (based on NTH's estimate outlined in the table above). For 2018, our design fees will be approximately 6.62 percent of the construction cost estimate, which is equal to a lump sum design fee of \$135,000.

We are currently developing a schedule for the watermain replacement at Holmes. Our objective is to have the watermain work completed before implementing Holmes' pavement repairs. NTH's proposed design schedule for the five 2017 pavement projects is as follows:
