We ended the school year with an enrollment of 6,292, and our original budget was built on the demographer's projection of 5,805. A budget amendment was approved in March to increase ADA estimates from 5,502 to 5,765. There is a second budget amendment on this agenda to increase our ADA and special populations to the end of the 5<sup>th</sup> six weeks and increase a few functions that are projected to exceed their budget by year-end. A third and final budget amendment will be included as information in the July meeting.
