



Re: Student Lunch Meal Price Increase



Due to the Healthy Hunger-Free Kids Act of 2010, signed into law December 2010, requiring schools to charge students of paid meals at a price that is on average, equal to the difference between the federal free meal reimbursements and any state reimbursements, and paid meal reimbursement. Schools that currently charge less are required to gradually increase their prices over time until they meet the requirement. Because our current lunch price does not meet the paid lunch equity price (\$3.00), we are required to increase our lunch price by ten cents.

### Current Paid Lunch Prices

Elementary \$2.50

Secondary \$2.75

### Proposed Paid Lunch Prices

Elementary \$2.60

Secondary \$2.85
