Superintendent's Report

Update: Superintendent Rappold reported on a few items; Wrapping up the end in terms as budgets, Business Office is at MASBO this week. Gwen is in the building wrapping up some things. Superintendent has met with Gwyn on department budgets which will be coming to the board. Working on finalizing the 2022 audit getting very close to be done, then they will move forward with the 2023 and 2024 audits.

Principal placements: Superintendent Rappold stated that the principal placements for next year have been set. They have started working with their leadership teams this week and are off to a good start. We have accomplished a lot in the last month.

Strategic Planning: Superintendent Rappold reported that the strategic plan is in the final form and should be ready to come to the board as a draft for final review soon.

Ms. YellowOwl asked about the vacant positions under principals/vice principals. Superintendent Rappold informed her that they interviewed on Friday, they had eight (7) applicants, two (2) from out of state and three (3) in district, two (2) out of district. HR Status Update: Interviewed for Principals, Assistant Principals, Secretaries at BHS, Child Care, and a Math Teacher. We are getting an Auto Shop Teacher. Still working on interviewing. Openings: 2 Kindergarten Teachers, 4 Sped. Teachers, Health Enhancement Teacher, Speech Therapy Assistant, 2

TA's, 5-2nd grade Teaches, 2-3rd grade Teachers, 4-4th grade Teachers, Music Teacher in the Elementary level, PCA, 6th grade Science Teacher, 2-8th grade Teachers, 2-Elective Teacher (BMS), BHS Home School Coordinator, Technology Teacher, ELA Teachers, 2-Science Teachers, 2-Math Teachers, Drivers Ed Teacher, Sped TA, Sped Teacher, Assistant Cook, 2-Custodians, Sped Nurse, Adaptive PE, School Psychologist, Speech Pathologist, moving a 9-month Bus Driver to a 12-month position which will open up (3) 9-month Bus Driver positions.
