# **MINUTES**

## **Members Present:**

### 1st review

- **518- DNR-DNI Orders-** The committee recommended no changes to this policy.
- **528- Student Parental, Family, and Marital Status Nondiscrimination-** The committee recommended minor changes as well as the MSBA suggestions to this policy.
- **601.3- Student Teaching and Internship-** The committee recommended minor changes to this Cambridge-Isanti policy. Director Kirkeide will follow up with how we do background checks for our student teachers.
- **606.5- Library Materials-** This item was brought back to the committee to determine whether language should be added to the policy regarding reimbursement for lost media materials. Administrators are currently gathering information to support a data-driven decision as well as creating language to place in student handbooks. This will be brought back in July after the student handbooks are approved.
- **611.1- Private, Parochial and Home School Share Services-** The committee recommended minor changes to this policy.
- **901-** Community Education- The committee recommended minor changes as well as the MSBA suggestions to this policy.
- **903.1- Sales Calls and Demonstrations-** The committee recommended no changes to this Cambridge-Isanti policy.

### **2nd Review of Policies**

- **205- Open Meeting and Closed Meetings-**The committee recommended minor changes as well as the MSBA suggestions to this policy.
- **414- Mandated Reporting of Child Neglect or Physical or Sexual Abuse-** The committee recommended minor changes to this MSBA policy.
- **506- Student Discipline-**The committee recommended minor changes to this policy as well as keeping our language that follows our current procedures.
- **623- Mandatory Summer School Instruction-** The committee recommended minor changes to this policy. Dr Bodey brought this to his team for review. He recommended several changes and the committee agreed to those recommendations.
- **722- Public and Data Subject Requests-** The committee recommended minor changes to this policy. **806 Crisis Management Policy-** This policy is reviewed annually. The committee recommends keeping our language that follows our current procedures.

## **3rd Review of Policies**

- **402 Disability Nondiscrimination Policy** The committee had great discussion about this policy and Director Kirkeide gave some clarification related to language questions. The committee recommended minor changes as well as the MSBA
- **522 Title IX Sex Nondiscrimination Policy, Grievance Procedures and Process** This was brought back to the committee because this policy needs to go back to the 2020 version of this policy along with the grievance process that exists within this version. The committee made minor changes to this policy.

### **Action Items**

- **501- Student Weapons Policy-** The committee recommended minor changes as well as the MSBA suggestions to this policy. Director Kirkeide brought this policy to the SROs for review. They did not recommend any changes.
- **520- Student Surveys-** The committee recommended minor changes to this MSBA policy. Director Kirkeide will work with Dr Bodey for some clarification.
- **534- Unpaid Meal Charges-** Director Nate Huff recommended changes to this policy and the committee agreed to these changes.
- **621 Literacy and READ Act-** The committee recommended minor changes as well as the MSBA suggestions to this policy.
- **723- Post Issuance Debt Compliance-** Director Kampa suggested minor changes to this policy which the committee agreed to.
