### I. SUPERINTENDENT'S REPORT

### A. Recognitions

- 1. <u>School Board Recognition Month:</u> Supt. Glaes recognized and thanked Board Members for their dedication to the District, students, and community.
- 2. <u>VHS Band Update:</u> Principal Keevin O'Neill gave a brief overview of the VHS band trip results and thanked Mr. and Mrs. Soekarmoen for their volunteerism. Mr. Rosier will be present at the February meeting to give a detailed report of the trip.
- C. <u>Legislative Update:</u> Supt. Glaes reviewed the latest legislative updates. President Knowles encouraged the audience to contact their Legislators and ask them to oppose using K-12 education School Aid Fund to pay for community colleges and university
- D. <u>Important Dates:</u> In addition to dates listed, there will be a late start early release day on Wednesday, January 12. This provides concentrated time for staff to work on data and curriculum alignment.

# A. <u>Budget and Finance Report - Steve Goss:</u>

- 1. <u>Budget Progress Report for the Month Ending December 31, 2010:</u> Asst. Supt. Goss reviewed the budget progress report for December 2010 showing total revenues of \$6,585,174; total expenditures of \$8,736,749; and deficiency of revenues over expenditures of -\$2,151,575.
- 2. <u>Amendment Report for the 2010-11 General Fund Budget:</u> Asst. Supt. Goss presented the amended budget and requested approval later on the agenda.
- B. <u>MI Merit Exam Results Keevin O'Neill:</u> Principal O'Neill compared District Merit Exam results to the State and Wolverine Conference. Mr. O'Neill explained what was being done to raise scores.

- C. <u>Transportation Department Annual Report Ric Beers:</u> Mr. Beers presented his report which exemplified safety and introduced the drivers to the audience. Mr. Goss thanked Mr. Beers and his department for their commitment to safety.
- D. <u>Performing Arts Center Annual Report Tim Fuller:</u> Mr. Fuller reviewed the events held at the PAC for the last year and stated it was a good year to be a student in the arts at Vicksburg.
- E. <u>Audience</u>: Didik Soekarmoen stated that he was proud to be from Vicksburg and fortunate to witness how the kids performed and behaved on the band trip. It was a huge undertaking and very successful.

Brad Geesaman welcomed Board members to a new year, and stated that teachers are excited. The Administration is doing an excellent job in working with them. They appreciate the open door policy.
