Subject: 2013 Bond Program: Bond Budget Transfer from Sound Engineering to Digital Age Technologies

Dear Ms. Smith:

When the technology contract was extended to include Niji-Iro Japanese Immersion Elementary School the public address system (CareHawk) and classroom sound amplification (TeachLogic) contract with Sound Engineering had expired and Sound Engineering was no longer taking on additional work. At this time, the district also has an existing contract with Digital Age Technologies for Community Room work. Digital Age is also capable of preforming the CareHawk work, and at the time, was the only authorized distributor and installer of CareHawk, as well as an authorized TeachLogic distributor and installer.

Sound Engineering's contract was for \$2,421,186.00 and was under this amount by \$207,441.29 when their contract was finalized.

The project team would like to recommend a budget transfer from the Sound Engineering contract to the Digital Age Technologies Community Room contract, for \$75,000.00 in order to move forward with the public address system and classroom sound amplification work. This would be sufficient to cover the work and any potential changes which may be encountered.

TOPIC:Approval of Bid Results for Elementary Community Room
Technology – 2013 Bond

RECOMMENDATION:
