SUBJECT (item as it will appear on agenda):

Approve the 3 year agreement with OU Campus to provide managed hosting solutions for WCJC's Internet, Intranet, and Faculty Web.

RECOMMENDATION:

Approve the 3 year agreement with OU Campus to provide managed hosting solutions for WCJC's Internet, Intranet, and Faculty Web for a total cost of \$161,454.00 over the 3 year period.

BACKGROUND/RATIONALE:

The current OU Campus content management system is maintained by WCJC IT staff, along with the servers for the WCJC Internet, WCJC Intranet, Faculty Web, and WCJC Calendar. Maintaining the WCJC Web presence on premise makes the websites more vulnerable to cyber-attacks, susceptible to natural disasters (Hurricanes and tornados), and to localized issues (electrical issues, equipment failure). The new agreement will allow WCJC's IT staff to convert to manage hosting solutions with OU Campuses Software-as-a-Service (SaaS) and Edge Hosting. This will significantly help WCJC achieve the goal of high availability and consistent web presence in any circumstance. The total cost for the 3 year period is \$161,454.00. The cost of the first year is \$56,500.00, year two is \$52,145.00, and year three is \$52,809.00.

I. Background / Summary of Project

A. Statement of the Problem

The WCJC websites and content are managed and maintained on premise making the websites more vulnerable to cyber-attacks, susceptible to natural disasters (Hurricanes and tornados), and to localized issues (electrical issues, equipment failure). The College website is depended upon to be used as a communication tool for students, faculty/staff, and the public. Students rely on the WCJC website to connect to online classes, register for classes, connect to online advisors, and make registration payments.

B. Rationale for Change

Having a web presence during a natural disaster is vital to continue communications with students, faculty/staff, and the public, such as information for campus closings. Having the WCJC websites hosted and managed off premise better reinforces a consistent web presence in any circumstance.

C. Overview of Anticipated Solution

The anticipated solution consists of two parts:

- Software-as-a-Service (SAAS) The Content Management System (CMS) WCJC is currently using is OmniUpdate from OU Campus. OU Campus offers Softwareas-a-Service to manage and host the content server and the software for the CMS.
- Managed Hosting OU Campus works with a third party vendor, Edge Hosting, to manage and host the servers housing the WCJC Internet, WCJC Intranet, WCJC Internet/Intranet Calendar, and WCJC Faculty Web.

II. Cost of Implementation

The first year OUCampus SAAS solution includes \$4,000 for professional services to help with the conversion. The first year for the Managed Hosting includes \$1,000 setup costs.

The first year cost has been requested in the MIS Infrastructure Architects FY18 operating budget. Future years will be included in the Manager of Technical Services operating budget.
