It was brought to Joliet Patch's attention that Joliet West HS Academy Coordinator Maureen Pulaski, who was the subject of an August Joliet Patch story about shoplifting crimes, may have been subsequently placed on administrative leave in the aftermath.

Joliet Patch submits this Freedom of Information Act request seeking access to A) any District 204 correspondence notifying Pulaski she was being placed on any type of leave from District 204 during the current 2025-2026 school year.

B) Patch seeks access to the calendar dates during the current school year that Pulaski was kept off-campus and therefore away from her regular administrative duties at Joliet West High School.

C) Patch requests access to any correspondence from the District advising Pulaski of her eventual return to her regular on campus administrative duties.

D) Last, Joliet Patch seeks access to any disciplinary action taken against Pulaski by the District in 2025 and or 2024. If no discipline has been taken against Pulaski during 2024 and or 2025, please advise that is the case.
