- Line 1 Tier one, year two of the voter approved operating levy from 2018. \$1,020 per pupil for taxes payable 2019 through 2021.
- Line 2 Local Optional is \$724 multiplied by 3,634.20 APU.
- Line 3 Transition revenue guarantees a district will not receive less money from changes in legislation.
- Line 4 Equity formula calculates the gap in district basic plus referendum revenue in the region.
- Line 5 Operating Capital is part levy (30%) and part state aid (70%). \$109 x Building Age Index Calc.
- Line 6 Q-comp is part levy (37%) and part state aid (63%). \$260 x Estimated Enrollment.
- Line 7 Reemployment is tied to a District's estimated unemployment insurance payments.
- Line 8 Up to \$36 per pupil unit for the costs of peace officers, drug prevention, and other efforts to improve school climate.
- Line 9 Mahtomedi's portion of safe schools levy for Intermediate District 916.
- Line 10 Funding available for academic and technical skills to succeed in future careers.
- Line 11 Capital projects is based on the net tax capacity (25,546,642) multiplied by 2.73%. NTC increased \$818k.
- Line 12 Long Term Facilities Maintenance (LTFM) levy \$380 per pupil multiplied by bldg. age ratio. Part gen. fd., part debt fund.
- Line 13 Funding availbale for Mahtomedi's portion of the OPEB abligation in excess of the OPEB trust balance.
- Line 14 Lease levy. Limit is \$212 x adjusted pupil units. Limit on Pay 20 levy is \$770,450.
- Line 15 Intended to pursue racial and economic integration and reduce disparities in public schools.
- Line 16 Prior year adjustments calculated by the Minnesota Dept. of Education.
- Line 17 CE programs provide learning and involvement opportunities for people of all ages.
- Line 18 Used to pay principal and interest on building project bonds.
- Line 19 Used to pay principal and interest on OPEB debt bond.
- Line 20 The preliminary proposed levy for payable 2020 taxes is \$14,828,759.61.
