Recognizing that every four years the stage curtains in our school auditoriums need to be flame-proofed, a bid document was prepared and the appropriate legal notice, which is attached, announcing a bid opening on June 12, 2013, was published in the May 30, 2103 issue of the <u>Oak Leaves</u>. Also attached is the list of vendors invited to bid on this work.

At the bid opening on June 12, 2013, only two bids were received (see attached bid summary). Recognizing the disparity between the two bids (\$60,742.80 and \$33,600), I requested the Director of Buildings & Grounds, to confirm that the low bidder understood the scope of the work to be done and he has assured me that Jose' Drapery understands the scope of the work to be undertaken and re-confirmed his bid price. Further, given that Jose' Drapery has not done work for us previously, a thorough reference check was conducted and the quality of the work performed has been documented as exemplary. Jose' Drapery did bid on this work in 2009 and would have qualified as the low bidder; however, their bid document was not complete. This time all paperwork submitted was in accordance with the bid requirements.

We are recommending award of this contract to Jose' Drapery in the total amount of \$33,600 and this recommendation will come to the Board for formal authority at its July 9, 2013 meeting.
