Z3 Solutions further recommends to the Board of Education a total project approval for the Phase Three Renovation Work of Lincoln Hall Middle School including Prime Trade Contract Awards as described above, Unassigned Costs and Allowances, General Conditions and Bonding/Insurance/Fee as further described within including Base Bid, Alternate #3, 5, 6, 8, & 11 for the Final Cost Estimate Sum of Seven Million Seven Hundred Seven Thousand Seven Hundred Sixty One and 45/100th Dollars (\$7,707,761.45).
