Mr. Gildea: Item number five, Mr. Nichols and Mr. DiLuggio.

Mr. Nichols: Thank you everybody for your time tonight. Nick and I would like to make a very straightforward request to you. We come to you tonight to extend the Middle School to include grade six.

Provide a full continuance of services to all our students regardless if they are special education status or not. What I find that there's an opportunity here to really meet the needs of our students K - 12 that require that social, emotional, a more therapeutic approach to access their education.

The supports that are in place at Raise Academy range from providing teachers with students who are really overwhelmed in the classroom to a more intensive more therapeutic base support that's provided through our social work team. We'd like to really do is to make sure we have that opportunity available for all students. We're looking at providing public education for all students who really do need to meet that consideration.

So it's clear to me that I request and Nick. Unless you have to add anything in as to the rationale and we can talk about what that would look like in terms of their eligibility. Mr. DiLuggio is here. Anything that you'd like to add?

Mr. DiLuggio: Not really. Nick put on the main point. I think it's important to have a space for any student.

Mr. Nichols: Thank you. We want to make sure we've exhausted all options. Are we providing them an opportunity to explore a more therapeutic environment for Raise Academy. When Nick and I were talking about the scope of those interventions and the duration of those interventions that we're really looking at a six week per trial for each attempt made. Once they're in there, give them an opportunity every 30 days to review their individual and program goals. And that we're staying on top of the newest addition. I think it's an opportunity to grow our program, and to extend the services that we provide to all students.

Mr. Gildea: Knowing a number of students who had gone to the program saved by the program and really turn the progress around by the program. How many students could comfortably sit in that program?

Mr. Nichols: Currently we have four middle school students that are enrolled and the Raise Academy. We feel that a 20-student cap that exists right now. I think there are 15 in person students at the high school. And there'll be four right now at the middle school. An opportunity to ensure that continue.

Mr. Gildea: Anybody have any questions. Ken, then Tara, then Dan.

Mr. Marcucio: Beginning with the 7th and 8th graders.

Mr. Nichols: That's correct. They will not be with the high school at all?

Mr. Marcucio: You've been on top of that?

Mr. Nichols: Yes, sir. I can give you some more information if you'd like.

Mr. Gildea: Ms. Hyder.

Ms. Hyder: This sounds like a good opportunity for the kids who obviously need it. My concern or question lies in and I think it might be more for Dr. Conway the behavioral conflict at the Middle School, I think that if I'm a 5th grade teacher or 5th grade staff member, I wouldn't want to automatically be thinking hey next year this child is kind of earmarked for a certain program as opposed to transitioning kids to the middle school and preparing transition meeting what the behavioral process is here at the middle school. And so I'm just wondering what this might look like in the future in terms of hopefully not earmarking kids to just go straight from 5th grade, not that it's a bad thing, but like you said before, we want kids with their peers as much as possible. So thank you. I think my question is more for Dr. Conway.

Dr. Conway: Sure great question. The current behaviors look at the history. Transition that Nick or James feel supported. First process looking at what the interventions were.

All tiers all documented at a period of time. Help make those decisions.

Ms. Hyder: Connection to elementary school. Do elementary educators need to understand more about Raise Academy?

Mr. Nichols: Part of that process is going to be forming that team. Support or find other avenues.

Mr. Gildea: Mr. Foley.

Mr. Foley: Do you anticipate a need for additional staff initially?

Mr. Nichols: The program does continue to grow. As far as staffing. High school and middle school academies. See if there is a need for additional support. Yes and also a yes.

Dr. Conway: Looking at staffing. Add to that contract. Those services are reimbursable. We don't want to bring students into the program without the right support.

Something like that or the content when you find that in the budget. Certain services to bring that on board in the terms of excess costs. So those services reimbursement under the excess costs. Additional support based

on student needs. Currently get this cost rate goes on reimbursed costs for certain serv that qualify under this grant.

Mr. Nichols: This year we've really taken as an initiative regular supports team we have a dedicated educational teacher. In addition to that our social worker and active roles in that program Structured supports that are there, on paper there.

Mr. Foley: One follow-up question would this program start this school year?

Mr. Gildea: Any other questions from the Board.

MR. Nichols: Thank you for your time.

Mr. Gildea: Item number 6. SRBI/Intervention Model for Math & ELA at Derby High School. Jennifer Olson and Rebecca Bell.

Ms. Olson: We do have Ms. Bell with me here tonight. We're very lucky at the high school we have 4 with certification. We'd like to talk about the overarching benefits.

Ms. Bell: Working specifically on the academic side. Scientific Research Intervention. Identification process require additional tiers. Tier II and Tier III. The key elements. Instructional intervention for research base. Make sure that the interventions are in place and how working with each student. Tier 1 strategy are focused more and more on the tiers. All students get the instruction in Tier 1 and then those students require further intervention in Tier II, the instruction a little more focused. We have smaller groups, more time, more focused for what the students required what they need in order to be successful.

For Tier II focusing on Tier II in what Ms. Olson talked about smaller settings to provide them with supports with their Math and English academics. Focusing on those two needs. Thank you.

Ms. Olson: Our goal reading and math intervention. We're calling it an intervention lab. So to prepare SRBI model at the high school, we have to do a lot of work. Without the key part of missing any Tier 1 instruction. Pull a student out of a class or have them miss. Lot of work with the master schedule.

To work with students in a smaller setting for 48 minutes a day. That's included in looking at math courses. Effectiveness and efficiency of how we're using our resources and our teachers. No additional staff members. What we need to do is to be able to offer this credit. Previously at Derby High School there was credit offered last period. Allowing that to be a .5 credit. And by scheduling math intervention labs students to be able to not be pulled from Tier 1.

Have now run away from the practice of students not meeting a benchmark from that class. And we put students behind the eight ball. We give students what they need. This is really a viable option for Derby High School.

Mr. Gildea: Thank you. Any questions?

Ms. Hyder: Do they have to have a certain score after they take a test or does a teacher recommend it. How does it work?

Ms. Bell: One is right now is SATs used in our classroom as well. really pinpoint where students are really trying to struggle. I think It's to really important to allow students to have a say in what they want to work on. Where they struggle and where they are strong as well. Third we would involve parents. It involves all this for the Team intervention teacher. Teachers, students and parents.

Mr. Gildea: Any other questions.

Ms. Olson: Teachers that will have them in their regular classroom as well.

Mr. Gildea: Mr. Marcucio.

Ms. Olson: Academic intervention put an SRBI model in place pose a challenge. Offer for Credit that is why we made it a priority this year.

Mr. Gildea: 379 and 381.

Mr. Izzo: The CARES Act.

Mr. Gildea: How much of that the money is spent through what our additional needs are, plexiglass.

Mr. Izzo: Plexiglass is in there. \$135,000 in there for PPE.

The last one. So in there we have 135,000 in there. Covers through September. It covers our expenses today.

Mr. Gildea: Additional expenses.

Mr. Izzo: Covers our expenses to date. It included cameras, included the cameras in the rooms, included cleaning supplies, included bus monitors, sanitation. Plus the masks.

Mr. Gildea: The additional costs incurred are covered here. But if there is a winter is worse and we start to have additional needs, do you have concern if that become an issue.

Mr. Izzo: I would be concerned right now. How we spent that money.

Mr. Gildea: Lines items. Is that like a line item, the 379 and the 284.

Mr. Izzo: Yes. That's actually broken out by supplies, other professional services. Right now I feel comfortable. Working at some point in time.

Mr. Gildea: That's what I'm saying.

Mr. Izzo: We're blessed that we have food services that we have. We're in the black. Look at all these places that are in the red.

Mr. Gildea: Thank you sir.

Mr. Izzo: So grants are an issue. I don't know whether this is an adjust. Get ready for the audit probably in late October.

Mr. Gildea: Ask a question Ken. Any questions on finance report.

Ms. Cannata: What voucher 1010. Then there's money back to parents.

Mr. Izzo: That's a check register. 1010, general funds. Those are refunds to some parents for a yearbook.

Good question.

Mr. Marcucio: How much money did we spend on PPE out of our budget, operating budget. How do we get that back into our operating budget.

Mr. Izzo: That's part of that CRF that's reimbursable. We are working on that.

Mr. Izzo: It comes from the State. The CARES Act. It's part of that.

XVI. COVID Positive Test Process

Dr. Conway: Update on COVID Positive Test Process. We had our first positive test late Friday night.

Elementary school, Irving School. Did an amazing job the school nurse there and Aimee are getting things in place.

People don't realize the role that school nurses play in this process.

Mr. Gildea: Use the microphone.

Dr. Conway: The nurses' lives has changed in all of this. Just like everybody else's. In coordinating the reports that go along with it. Follow the guidelines that were provided to us explained to us. As we get into the process Department of Health is a State Model. It provides the necessary resources us to do the recording and contract tracing provide people who are most impacted with the news. Continue with how those people able to identify in the school. So we continue to have a responsibility. That's the responsibility we have to balance. Both in our role and the role as the nurses to maintain the confidentiality.

Making contacts, it's a small group. Over 200 contacts have been made in just one case. We are overwhelmed with one person doing all that work. We could have done the work ourselves in a matter of minutes.

Our second case came on Tuesday morning. Documentation we have for the notes take that process. Change the order. We would actually immediately upon notification. We do our own contact to our staff and students and our families. Getting those contacts done within a reasonable period of time. We are trying to break up the list in a very efficient way to get to people and families before it's out in the community.

Very specific terms of the guidelines. Second time around contact first put it out in the community, name the school as well. There's still a lot of questions people try to do the right thing. They are calling back to ask follow-up questions. Should I go get tested. We're providing guidance in that process and we'll continue to do that for any cases. Second time around is smoother and create additional documentation.

We are here for help in any way we can. We get an answer. Certainly, with your coaching staff, the difference I guess possibly with an organization, they're not in session every day they may not know the protocols to follow. They can always call me. Keep the number for Naugatuck Valley Health Department. Jeff will guide them from there. You can just call.

Mr. Gildea: Using the term community member. Is that Department of Education standard?

Dr. Conway: Not identify if it's staff or student.

Mr. Gildea: I'm a parent. Staff member and/or a student. I mean a class of 20 kids. I know other school systems do it.

Dr. Conway: Responsibility we have to protect the identity. We have a responsibility a professional responsibility to protect the identity to HIPPA laws. Can't dispose the names or provide information to be able to identify if it's a student.

Mr. Gildea: I guess in the school system, whether you're a parent knowing its a student. I think about that a lot. There doesn't appear to be a full lot of data in the State. The State does an amazing job counting the how many people are positive, how many people are hospitalized, but yet the school system, but to me we should be able to know of the community of the 350,000 students in school, 510 have it and three percent is quite higher than the State average. So a student to stay is doing daily numbers, I think we fall short of the schools system.

Dr. Conway: I agree. So as of last Friday our nurses are recording on a daily basis to the Department of Public Health. If we received a positive case, State Department of Ed and then report it to the Department of Public Health.

Keep in mind talked about today, if they tested positive, if they're not reporting to school. At what rate are they contracting it. I don't know any case where schools today that have resulted it within the school building.

Mr. Foley: Dr. after the cases were reported in the school system, did you see the significant increase of students opting out of in person learning and going to distant learning.

Dr. Conway: We have not at this time.

Mr. Marcucio: Do we have any students who are doing distance learning that are also playing sports?

Dr. Conway: I know the kids are playing sports for Derby or playing sports for Little League. Yes, we allow them to.

Ms. Hyder: Celebrate the kids achievement. It would help families understand give that information that number for students. There are school districts who share this information. Can this happen in Derby that support contract tracing? Help with any practices for contract tracing.

Dr. Conway: We haven't changed any as of right now. Certainly something we can continue to look at. So we don't have to rely on memory.

We err on the side of caution. The team got together again, make those 23 calls to get the message out.

Mr. Gildea: Okay. Any other questions.

Mr. Kurtyka: Are we still taking temperatures before school to get on the bus.

Dr. Conway: We have parents taking them and staff taking them on their own. There's a health questionnaire to complete on a daily basis.

Mr. Kurtyka: I think we talked about they can't get on the bus if they have a fever?

Dr. Conway: They can't.

Mr. Kurtyka: We're not checking them coming off the bus coming into the building?

Dr. Conway: No, we're not.

Mr. Kurtyka: You know and I know about the HIPPA laws are very strict. I kind of agree with Dr. Conway leave it as a community member. As long as they do that on their own, that's fine. Identify the person as a community member instead of trying to pinpoint who it is.

Dr. Conway: Articles are very specific that they didn't get the information from the district. It's a member school community. I'm not sure the upside to us even naming the school student or staff.

Mr. Gildea: The upside to me in a world that decisions are driven by data. But the State of Connecticut monitors the daily percentage rate of every State in the Country and they make decisions on that. In my opinion, it's the single greatest health issue that has faced this country in my lifetime. So to me I just think the community has a right to know.

Dr. Conway: That information will be available to the State. We have to report to the State.

Mr. Gildea: That's fine. Any other questions.

Ms. Netto: It's a little bit disappointing that we are not putting it out. Not naming names. It's the world we live in right now.

Ms. Hyder: A personal situation when the first case was out the way the community was, because I as a mom, didn't know how many details. I have a son who's a little league umpire right here in town. I told my son don't get too close. I should give him that advice. And again, just to be safe.

Mr. Gildea: Anybody want to add in weigh in comment. Any other questions. Mr. Kurtyka.

Mr. Kurtyka: Dr. Conway can one of your staff call the Department of Health or the Department of Education see the guidelines about the release of this information. See the rules from them. Thank you.

Mr. Gildea: Okay. Good suggestion George.

Ms. Caggiano: Publicly again Tracy, Mr. Rafferty ability to have a Team was really that day. I couldn't have done it without them.

Mr. Gildea: I appreciate that. Just for the sake of having more information. I respect those opinions. Want to get more information. It's a serious topic. Any other questions.
