Agenda Item: Consider and take action regarding approving the purchase of Body Cameras for the JISD Police Department from Bond 2022.

CONSENT ITEM

RECOMMENDATION:

To approve the purchase of Body Cameras for the JISD Police Department from Bond 2022.

IMPACT/RATIONALE:

Proposition A of the 2022 Judson ISD Bond project provided funding for the purchase of safety and security equipment for all campus sites. JISD Police conducted an evaluation of body camera technologies to support the department. Judson ISD Police selected the Axon Enterprises Inc. Body Worn Camera in December 2022 following the passage of the 2022 Proposition A Bond Proposal by the JISD Community. The system replaced the existing body cameras utilized by the department. In January of 2023, a total of 31 cameras to support the existing department. The department has increased due to recent legislation and the need to support our individual school communities. Due to the expansion of the department, additional cameras are needed to support officers. This purchase is to request an additional 14 devices and software support to mirror the prior purchase approved in January 2023 at a cost of \$54,431.58 to be paid out of Bond 2022 funds. The Axon Body Worn Camera system was selected based on the 24/7 customer service guarantee, the 5 year warranty, cloud storage capabilities, and battery life that extends 12+ hours. Other similar camera systems provide similar features, but do not meet the same battery life, customer service availability or warranty coverage that the Axon system provides. Axon is also the only company that offers CEW Weapons that integrate directly with the cameras and automatically turn on the body camera when TASER weapon is turned on. Axon is also the camera utilized by Bexar County, San Antonio Police Department and other Texas school districts such as Houston ISD, Dallas ISD, San Antonio ISD, Austin ISD, Lubbock ISD and others. Axon camera footage automatically syncs with Evidence.com which is the portal utilized and directly accessed by the District Attorney's office. The upload technologies through evidence.com would allow our officers to easily upload to the District Attorney's office without needing to download and transfer the footage via drive or other mechanisms as is the current practice. The accessibility of files to the DA is an added benefit that this product offers.
