

**RESOLUTION AUTHORIZING THE
HONORABLE DISMISSAL OF TEACHERS**

WHEREAS, the Board of Education has received reports and recommendations from the Superintendent and members of the administrative staff concerning the number of teachers needed to be employed and the types of teaching service needed for the next school term;

WHEREAS, the Board of Education is required to notify teachers of honorable dismissal at least forty-five days before the close of the school term due to the Board's decision to decrease the number of teachers employed by the Board and/or to discontinue some particular types of teaching service; and

WHEREAS, the Board of Education has determined to decrease the number of teachers employed by the Board and/or to discontinue some particular types of teaching service;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of Bloomingdale School District 13, DuPage County, Illinois, as follows:

1. The teachers named in Exhibit 1 shall be honorably dismissed from the teaching position identified in Exhibit 1 effective at the close of the 2021-2022 school term. The notice of such action shall be substantially in the form of the attached Exhibit 2a or 2b, as determined by the teacher's employment status, evaluation rating and/or seniority.
2. The Superintendent or designee shall deliver by personal service the notices of honorable dismissal and a copy shall also be sent by regular mail. If personal service cannot be made, the notices shall be sent by certified mail, return receipt requested.
3. This Resolution shall be in full force and effect upon its adoption.
