BACKGROUND:

The US Chess Federation announced the 2024–2025 Title I Travel Grant Fund. This program financially supports eligible affiliates serving Title I Schools to attend US Chess-run National Scholastic Events. This program is part of US Chess's commitment to improving access among underrepresented communities and reducing financial barriers to participation in national events as the applicant must be serving a Title I School or the Title I School itself must be an affiliate. Paredes Elementary applied and was granted the Title 1 Travel Grant to support student participation in the Kinder-1st grade Chess Team.

There is no cost to the district.

RECOMMENDATION:

Recommend approval to accept Paredes Elementary's request to accept the Grant in the amount of \$7,500 for travel expenses from US Chess Federation at no cost to the district.

Award Contract Conditions

- 1. Parties. This Award Contract (hereinafter "Award") is entered into on the date first set forth above, by and between the United States of America Chess Federation (hereinafter the "US Chess"), an Illinois not-for-profit corporation organized pursuant to Section 501(c)(3) of the Internal Revenue Code (26 U.S. Code § 501(c)(3)) and Dr. Americo Paredes Elementary (hereinafter "RECIPIENT"), a(n) Title 1 organization having an address of 3700 Heritage Trl, Brownsville, TX 78526.
- 2. <u>Period of Performance</u>. The period of performance of this Award shall start on Nov. 20, 2023 (the "Commencement Date") and end upon the earlier of (i) the date that Project Scope of Work is completed or (ii) May 31, 2024 (the "Period of Performance"). The RECIPIENT must complete the Project Scope of Work within the Period of Performance. US CHESS, at its sole discretion, has the right to provide an extension of the Period of Performance.
- 3. Project Scope of Work. The RECIPIENT agrees to perform the scope of work tasks identified in Part II, page 1, of this Award (the "Project Scope of Work"). In fulfilling the terms of the Project Scope of Work, RECIPIENT shall list the United States of America Chess Federation as sponsors on advertisements promoting the Project Scope of Work, including, without limitation, fliers, promotional materials, posters, electronic mail, and social media.
- 4. Payment/Return of Funds. US Chess may request that RECIPIENT return any unexpended Grant funds remaining at the end of the Period of Performance. US CHESS reserves the right to discontinue, modify or withhold any payments to be made under this Award or to require a total or partial refund of any Grant funds, if, in US CHESS' sole discretion, such action is necessary: (1) because RECIPIENT has not fully complied with the terms and conditions of this Award; (2) to protect the purpose and objectives of the Grant or any other charitable or educational purposes of US CHESS; or (3) to comply with any law or regulation applicable to the RECIPIENT, to US CHESS, or this Award.
- 5. <u>Deviation & Waiver</u>. The RECIPIENT shall not deviate from this Award. Further, the failure of US CHESS in any instance to insist upon a strict performance of the terms of this Award shall not be construed as a waiver or relinquishment for the future of the Period of Performance. No provision of this Award may be waived or amended, except that US CHESS may by written instrument and reasonable notice to recipient, waive, amend, or modify this Award consistent with applicable Federal, State, and local law.
- Reporting Requirements. RECIPIENT whose Period of Performance extends for more than fourteen (14) calendar days must 6. inform US CHESS of their progress on the Project Scope of Work at least each 21 (21) days from the commencement of the Period of Performance. RECIPIENT shall submit a written report to US Chess within forty-five (45) days after the end of the Period of Performance (the "Report"). The Report shall include testimonials, stories, and photos of those individuals who participated in the Project Scope of Work and those individuals who benefitted from the Project Scope of Work. RECIPIENT shall use its commercially reasonable efforts to obtain the written consent of those individuals who had their photos taken in conjunction with the Project Scope of Work so that US Chess may lawfully use the photos on its the website, social media sites, e-newsletters, and other public media. RECIPIENT shall provide a copy of the written consents to US Chess in the Report. The photos must identify the names of those individuals who consented to the use of their images for US Chess purposes, which such use shall be considered commercial use. The Report shall also include the number of individuals served by the Project Scope of Work and the number of those individuals who were female. The Report shall also include a summary of the activities completed in connection with the Project Scope of Work along with a summary of the lessons learned by the participants from the activities. The Report shall include a section pertaining to RECIPIENT's future plans to further engage the individuals who participated in the Project Scope of Work, in chess. Finally, the Report shall include an accounting of the Grant funds expended in RECIPIENT's performance of the Project Scope of Work. RECIPIENT shall provide such additional information, reports, and documents as US CHESS may reasonably request pertaining to the Project Scope of Work.

RECIPIENT Representation and Warranties.

- a. Parties. This Award Contract (hereinafter "Award") is entered into on the date first set forth above, by and between the United States of America Chess Federation (hereinafter the "US Chess"), an Illinois not-for-profit corporation organized pursuant to Section 501(c)(3) of the Internal Revenue Code (26 U.S. Code § 501(c)(3)) and Lenoir City High School (hereinafter "RECIPIENT"), a(n) Title 1 association having an address of 1485 Old Hwy 95 Lenoir City, TN 37771.
- b. The Grant shall be used for the Project Scope of Work, and not for any other purpose.
- c. It shall not use the Grant to lobby or otherwise attempt to influence legislation, to influence the outcome of any public election, or to carry on any voter registration drive.
- d. It accepts responsibility for complying with this Award's terms and conditions and shall exercise full control over the Grant and the expenditure of Grant.
- e. RECIPIENT shall, at its own expense, carry and maintain in force beginning on the Commencement Date, and at all times thereafter, commercial general liability insurance with limits of \$1,000,000.00, combined single limit bodily injury and property damage, per occurrence and in the aggregate. RECIPIENT agrees to provide US Chess with certificates of insurance evidencing coverage by the Commencement Date and, thereafter, within ten (10) days of US Chess' written request. A RECIPIENT using umbrella insurance will provide evidence of that coverage by the Commencement Date. Any new policy of insurance obtained under Section 7(e) of this Subaward shall name US Chess as additional insureds. No party named as an additional insured shall incur any liability for the payment of premiums for any such policy. Each policy shall have a notice of cancellation endorsement that provides that a policy may be cancelled by the company by giving to the insured and the additional insureds indicated on the certificates of insurance issued during the term of the policy, at least thirty (30) days written notice of cancellation, or in the case of non-payment of premium, at least ten (10) days' written notice of cancellation.
- f. RECIPIENT shall, at its own expense, conduct background checks on all staff affiliated with this Award. If a current background check is on file with RECIPIENT or with US CHESS, this requirement is considered waived.
- g. RECIPIENT agrees to adhere to all US Chess rules and policies, including the Safe Play policies.
- 8. <u>Indemnification</u>. RECIPIENT shall indemnify US CHESS and shall hold US CHESS harmless from all debts, claims, actions, losses, damages, and reasonable attorneys' fees and costs, to the extent caused by or arising out of RECIPIENT's breach of the terms and conditions of this Award or RECIPIENT'S performance of the Project Scope of Work; provided, however, that RECIPIENT shall not be liable for special, indirect, or consequential damages that may arise from or be related to its breach of this Award. Further, any award for damages against US CHESS shall not include special, indirect, or consequential damages that may arise from or be related to its breach of this Award.

Miscellaneous.

- a. The headings contained in this Award have been inserted for convenience only and in no way define or limit the scope of interpretation of this Award.
- b. This Award represents the full agreement of the parties, and supersedes all prior and contemporaneous agreements and understandings, if any, relating to the substance hereof between or among them. This is a fully integrated document. This Award may be amended only by a signed written agreement of all parties hereto.
- c. In the event any of the provisions of this Award are deemed to be invalid, illegal or unenforceable, those provisions shall be severable from the remainder of this Award, which shall continue, in full force and effect.
- d. It agrees to allow US CHESS to publicly announce the award of the Grant to RECIPIENT, including the name of the RECIPIENT, any partnering organizations, the Award Amount, the project location, and a general description of the project and its benefits.

e. This Award shall be construed in accordance with and governed by the laws of the State of Missouri. It may be executed in any number of counterparts which together shall constitute but one and the same, instrument, and will bind and benefit US Chess and RECIPIENT and their respective successors. This Award may not otherwise be assigned by RECIPIENT without US Chess' prior written consent.
