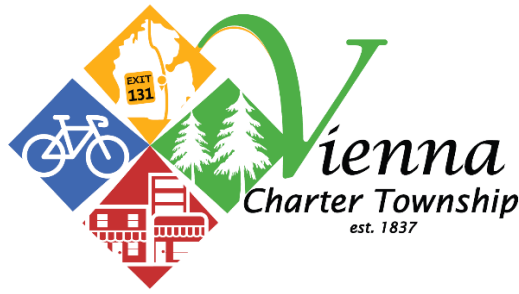

This agreement between the Charter Township of Vienna and The Clio Area Board of Education pertains to the two (2) Safety Resource Officers (SROs) provided by the Genesee County Sheriff’s office.

The SRO(s) are paid for by the Charter Township of Vienna under a contract with the Genesee County Sheriff.

The SRO(s) are to be utilized for Clio school functions at the discretion of the Superintendent of the Clio School District.

Any overtime incurred in the course of providing services for this agreement will be in a separate invoice, as per section 4.4 of the School Resource Memorandum of Agreement.
