Presentations/ Recognitions Guyer High School graduates Cale Golden and Audrey Lee earned the highest possible honor at the UIL State Solo and Ensemble Contest this past May. Both Cale and Audrey were awarded medals as "Outstanding Performers," meaning in addition to receiving Superior 1 ratings, they were also named the most outstanding performer in the state for their instrument.

Less than 300 students statewide received the honor of Outstanding Performer. Cale's performance earned him the distinction of Outstanding Performer on Bb clarinet. Audrey's performance earned her the honor of

Outstanding Performer on violin.

Kennedy Modica, a sixth-grade student at Crownover Middle School, was named to the Texas Choral Directors Association (TCDA) Texas Elementary Honor Choir this past spring. Kennedy was one of 78 altos selected, and less than 160 students statewide received the honor of being selected to the Texas Elementary Honor Choir. She received this recognition while a fifth-grade student at Hawk Elementary.

Discussion of Certified Tax Values, Tax Rate and Chapter 49 Dr. Scott Niven, Deputy Superintendent presented to the Board an overview of the Certified Values and Tax Rate and Chapter 49. At the September 26th Board meeting the Board will be approving the Certified Appraisal and Tax Rate and the Tax Rate Ordinance.

With the passage of Senate Bill 2 it will establish \$12 billion in tax relief for homeowners and commercial property and for the state to place more money into education. With voter approval the Homestead exemption will increase from \$40,000 to \$100,000. Senate Bill 2 also establishes a 20% appraisal cap on non-homestead residential and commercial real property valued at less than \$5 million beginning in 2024. The more tax collections that the District receives, the less state revenue the District gets which is an inverse relationship for every school district.

Chapter 49: Local Revenue in Excess of Entitlement or also known as recapture. Chapter 49 is what used to be referred to as Robin Hood. This section of the Texas Education Code (TEC) makes provisions for certain school districts to share their local tax revenue with other school districts. These provisions are sometimes referred to as "share the wealth" or "Robin Hood" plan because recaptured funds are redistributed by the school finance system to assist with the financing of public education for all school districts.

Discussion of House Bill (HB) 3 Safety & Security Update Dr. Jeff Russell, Area Superintendent presented information on HB3. The 88th Texas Legislative Session included the passage of House Bill 3 ("HB 3"). HB 3 amended Section 37.0814 of the Texas Education Code, which now requires an armed security officer on each district campus. Currently, Denton ISD uses School Resource Officers ("SROs") in all secondary schools and some of the elementary schools. The District has Interlocal Agreements in place with several local municipalities allowing on-duty Police Officers to be placed in schools as SROs. Denton ISD is currently working to grow the number of district armed personnel to meet the state requirements. Statewide, there is a shortage of law enforcement personnel along with public education funds to employ them.

Discussion of PediPlace Partnership

Dr. Charlene Parham, Area Superintendent and Nicole Goodman, Director of Health Services presented an overview of the Pedi Place Medical Clinic partnership. The Pedi Place clinic will provide care to students who currently lack access to care and allow them to return to class more quickly. Currently 12% of Denton ISD area is uninsured and has barriers to care due to transportation issues.

Dr. Susannah O'Bara, Deputy Superintendent for Academic Programs provided the current enrollment numbers. As of today, Denton ISD has 32,618 students enrolled.
