

## ELECTION CANVASS AND RUNOFF ORDER

A RESOLUTION OF THE BOARD OF TRUSTEES OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT OF COLLIN COUNTY, TEXAS, CANVASSING THE ELECTION RETURNS OF THE JOINT GENERAL ELECTION OF MAY 9, 2015, FOR THE ELECTION OF THREE (3) PLACES ON THE BOARD OF TRUSTEES, PLACES 7, 8 AND 9; ORDERING A RUNOFF ELECTION FOR JUNE 13, 2015, FOR THE PURPOSE OF ELECTING ONE (1) MEMBER OF THE BOARD OF TRUSTEES OF COLLIN COUNTY COMMUNITY COLLEGE DISTRICT FOR TRUSTEE PLACE 7; DESIGNATING LOCATION OF POLLING PLACES; PROVIDING FOR EARLY VOTING; SETTING A TIME FOR CANVASSING OF ELECTION RETURNS; AUTHORIZING PUBLICATION OF THIS RESOLUTION; STATING OTHER ITEMS NECESSARY TO THE ELECTION PROCESS; PROVIDING FOR SAVINGS, REPEALING AND SEVERABILITY CLAUSES; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Board of Trustees of the Collin County Community College District of Collin County, Texas ("Board of Trustees") duly authorized an election to be held within the Collin County Community College District ("College") jurisdiction on May 9, 2015 (the "Election"), for the purpose of submitting to the resident qualified electors of the College a ballot for the purpose of electing three (3) members to the Board of Trustees, Places 7, 8 and 9; and

**WHEREAS**, the Collin County Election Administrator that held said Election has duly made the return of the results thereof, and said returns have been duly delivered to this Board of Trustees; and

**WHEREAS**, there were cast in said Election 15,761 early votes as shown in the official election results heretofore attached as Exhibit "A" made a part of this Resolution, lawfully submitted to the Board of Trustees of the College, and filed with the Election Secretary of the College; and

**WHEREAS**, there were cast in said Election 8,551 election day votes as shown in the official election results heretofore attached as Exhibit "B" made a part of this Resolution, lawfully submitted to the Board of Trustees of the College, and filed with the Election Secretary of the College; and

**WHEREAS**, the Combined Early Voting and Election Day Accumulated totals (cards cast) resulted in the following:

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT;**

**SECTION 1. Findings Incorporated.** The findings set forth above are incorporated into the body of this Resolution as if fully set forth herein.

**SECTION 2. Election Results.** As a result of said Election, and in conformity with the law, the following are hereby declared to be elected:

**Bob Collins** is hereby declared elected to Board of Trustee Place 8.  
**Andy Hardin** is hereby declared elected to Board of Trustee Place 9.

**SECTION 3. Runoff Election Called.** No one individual received a majority of votes to Board of Trustee Place 7 as a result of said Election. Therefore, the Board of Trustees hereby calls a runoff election ("Runoff Election") to be held in and throughout the College district, on June 13, 2015, for Board of Trustee Place 7 between the following candidates:

**Collin Kennedy**  
**Jim Orr**

**SECTION 4. Conduct of the Runoff Election.** The District President is authorized to enter into a contract with political subdivisions in a runoff with Collin County Community College District's same election calendar and full service jurisdiction in Collin County necessary to conduct a joint election in accordance with the Texas Election Code, Title 16, Chapter 271 and other applicable statutes. Further, the District President and his designee, in consultation with the Attorney for the Board, are hereby authorized to take any and all actions necessary to comply with the provisions of the Texas Election Code and any other state or federal law in conducting the election herein ordered, even when not expressly authorized herein.

**SECTION 5: Early Voting.** That early voting by personal appearance will begin Monday, June 1, 2015, and continue through Tuesday, June 9, 2015, on the dates and at the times and locations set forth in **Exhibit "C"**.

The Collin County Elections Administrator located at 2010 Redbud Boulevard, Suite 102, McKinney, TX 75069, shall serve as the Early Voting Clerk for the June 13, 2015 runoff election (as per Sect. 2.053 of the Texas Election Code).

Application for early voting ballots by mail should be mailed the Collin County Elections Administrator; 2010 Redbud Boulevard, Suite 102, McKinney, TX 75069. Early voting shall be conducted at the sites designated by the Collin County Elections Administrator.

**SECTION 6: Voting Equipment.** In accordance with Section 123.001 of the Texas Election Code, the Premier Voting Systems AccuVote TS R6 (v. 4.6.4) and the TSX R7 (v.4.6.4) approved by the Secretary of State is hereby adopted for the early voting period and election day on June 13, 2015, and the Premier Voting Systems AccuVote OS (Optical Scan) will be used to tabulate mail ballots.

**SECTION 7: Publication.** The Board of Trustees shall publish a notice of the runoff election in a newspaper of general circulation in Collin County at least once, not earlier than the 30th day nor later than the 15th day, before election day as provided in Section 4.003(a) (1) of the Texas Election Code;

and shall be posted on the bulletin board used for posting notices of the Board of Trustees meetings not later than the 21st day before election day. A copy of the published notice that contains the name of the newspaper and the date of publication shall be retained as a record of such notice, and the person posting the notice shall make a record at the time of posting stating the date and place of posting in accordance with Texas Election Code Section 4.005.

**SECTION 8: Canvass of Runoff Election.** That the Board of Trustees will conduct a canvass of the returns from the June 13, 2015, runoff election on June 23, 2015 at 12:00 PM in Room 400 at the Collin Higher Education Center, 3452 Spur 399, McKinney, TX 75069.

**SECTION 9: Spanish Translation.** That simultaneously with the adoption of this resolution, there is adopted a Spanish version of the resolution.

**SECTION 10: Savings/Repealing Clause.** All provisions of any Resolution in conflict with this Resolution are hereby repealed to the extent they are in conflict; but such repeal shall not abate any pending prosecution for violation of the repealed Resolution, nor shall the repeal prevent a prosecution from being commenced for any violation if occurring prior to the repeal of the Resolution. Any remaining portions of said Resolutions shall remain in full force and effect.

**SECTION 11: Severability.** Should any section, subsection, sentence, clause or phrase of this Resolution be declared unconstitutional or invalid by a court of competent jurisdiction, it is expressly provided that any and all remaining portions of this Resolution shall remain in full force and effect. Frisco hereby declares that is would have passed this Resolution, and each section, subsection, clause or phrase thereof irrespective of the fact that any one or more sections, subsections, sentences, clauses and phrases be declared unconstitutional or invalid.

**SECTION 12: Effective Date.** That this Resolution is effective upon adoption by the Board of Trustees and that this Resolution shall be signed by the Chairman of the Board and attested by the Secretary of the Board.
