Motion by Dave McGee, second by Jen McNamee designating the fourth Monday of each month at 7:00 p.m. in the Nevis School as the official meeting time and place for school board meetings, with the exception of May when it will be held Tuesday after Memorial Day. Work sessions will be held Mondays prior to the regular monthly school board meetings at 6:00 p.m. in the Superintendent's office with the exceptions as follows: February 10 instead of February 18 and June 16 instead of June 23. A quorum of four board members must be in agreement in order to change the dates of work sessions. Notice of any agreed upon work session date changes are to be sent via email three days prior to the work session. Motion carried unanimously.

Motion by Aimee Plumley, second by Jen McNamee designating the Park Rapids Enterprise as the official newspaper of the District. Motion carried unanimously.

Motion by Dave McGee, second by Aimee Plumley to approve the board compensation to remain the same as it was for 2024. Motion carried unanimously. The 2025 annual compensation amounts are as follows: \$1,020.00/Board Member, \$408/Board Chair, \$178.50/Clerk, \$153.00/Treasurer, \$66.20/meeting 4 hours

or less and \$127.50/meeting over 4 hours. Travel allowances will remain as follows: \$8.00 breakfast, \$10.00 lunch, \$13.00 supper, mileage at the federal reimbursement rate when using a private vehicle when a school vehicle is not available and \$.18 per mile when using a private vehicle when a school vehicle is available. Motion carried unanimously.

Activities of scooterball and BINGO are planned for 7th period Wednesday for students in grades 7-12. A pepfest will be held Thursday. The week concludes with a semi-formal dance Saturday, February 1 from 7:30-10:30 for students in grades 9-12.

Board members reported attending the Minnesota School Boards Association (MSBA) winter conference, a Knowledge Bowl meet, a track clinic, and Community Education meeting.

Certified staff representative Kelly Holmin-Bennett reported first graders are learning where states are located and facts about the state through correspondence they are receiving every day. So far, they have received letters from 31 states and four countries. Hannah DeLaHunt indicated PTA and elementary staff are working to organize the annual Read Across America event. The 100th day of school will be February 10. And the robotics team gave demonstrations at the Minnesota School Boards Association recently held in Minneapolis.

Principal Michaelson's report included classes resumed inperson January 2 for students in PreK-12. Semester II/Quarter 3 began January 21. Grades K-6 have finished their winter NWEA assessments. The One Act Play actors and crew traveled to Pequot Lakes to participate in the sub-section competition where they finished in first place. They travel to West Central High School in Barrett Saturday, February 1, for the Section competition. Grace McNamee and Eli Klimek have been selected to represent Nevis School as the MSHSL Triple 'A' nominees. MSHSL Triple 'A' recognition banquet will be held in Mahnomen February 5. Mid-quarter 3 is February 19. A 2-hour late start is scheduled for February 12 for all students. There will be no school February 14 for teachers' flex day and February 17 for Presidents' Day. Wrestlers will compete at the section team tournament in Holdingford February 14 and the individual section tournament in Cass Lake-Bena February 21-22. And, the music ensemble contest will be held at the W-H-A High School February 26.

Superintendent Parks reported meeting with the Hubbard County Auditor to discuss the upcoming building referendum. Lynne Gustafson and Aimee Plumley also attended this meeting. Early voting and absentee voting is scheduled to begin February 21 with the referendum to be held April 8. Dr. Parks also attended the MSBA conference January 15-17.
