## Curriculum Reviews: K-5 ELA Curriculum Review

- **Grades 3-5:** Our grades 3-5 teachers have completed their pilot and review of *Collaborative Classroom*. Following the essentials literacy rubric, the team, along with Katie Spisich and myself, has recommended *Collaborative Classroom* for South Meadows. Pilot teachers are excited to share this decision with staff in December and present it to the District Curriculum Council (DCC) and the board in January.
- **Grades K-2:** K-2 teachers identified differing literacy needs for younger learners. Together with myself and Casey Wescott, we decided to pilot *Bookworms*, which better addresses foundational literacy development at the K/1 level. Staff are optimistic about the new pilot and anticipate positive outcomes.

## **Professional Development:** November 1 DPPD

- Personalized PD Paths: Staff began the day engaging in tailored professional development sessions led by our instructional coaches.
- **Building Goals:** Teachers worked collaboratively with their building leaders to address school improvement goals.
- **Department Collaboration:** The day concluded with focused departmental and grade-level meetings, fostering alignment on instructional strategies.

# Sex Ed Advisory Board Update

- **Meeting Overview:** The board convened on November 11 to review student surveys and begin developing a unified curriculum rubric for assessing current and potential new materials.
- Next Steps:
  - Students' knowledge and perceptions of the curriculum will be assessed post-unit during the 24/25 school year.
  - The team will finalize the recommended curriculum auditing tools in the coming weeks and begin the audit in December.
