## Purpose

The purpose of this memo is to request approval for the procurement of instructional materials, clinical services, tuition and professional learning for the Student Services Department that involve contract and contract renewals that exceed \$25,000. The current vendors that require consideration for approval are outlined below by category. The anticipated contract obligations total \$3,355,104.38. The contracts that rely on IDEA grant funds total \$351,131.32. Of the \$2,164,987.00 earmarked for out-of-district tuition, \$1,731,989.60 is reimbursable by the Illinois State Board of Education at a rate of 80%. # **Out of District Tuition**
