#### Consider Agreement For The Purchase Of Attendance Credits From The State

Approved an *Agreement for the Purchase of Attendance Credits* with the State for the 2011-12 school year and authorized the Superintendent to submit a "letter of intent" to the Commissioner of Education describing actions underway in the District to reduce its property wealth per student to the State equalized wealth level. The District currently expects to pay approximately \$1.1M in equalization ("Robin Hood") payments for the upcoming year.

# Consider Proposing A 2011 Tax Rate And Scheduling A Public Meeting To Discuss The 2011-2012 Budget And The 2011 Proposed Tax Rate

On the recommendation of Dr. Holacka, a motion was made by Mr. Damian and was seconded by Mr. Sharp to propose a 2011 tax rate of \$1.2415 per \$100 of assessed value, with \$1.0400 designated for the purpose of maintenance and operations, and \$0.2015 designated for the payment of principal and interest on the District's bonded indebtedness.

Motion passed unanimously.

In addition, on the recommendation of Dr. Holacka, a motion was made by Mr. Sharp and was seconded by Mr. Koch to approve publishing a notice for a public meeting to discuss the 2011-12 budget and the proposed tax rate, scheduled for August 23, 2011.

#### **REPORTS**

#### **Proposed RV Park For Freeport**

Jeff Pynes, City Manager of Freeport, provided the Board with a presentation of the proposed "Luxury RV Park" to be located between Brazosport HS and Freeport Intermediate. Mr. Pynes explained that his experience with this developer has been positive and that he only builds first class properties. The target tenants will be those with \$1M motor coaches. The only entrance/exit will be on 2<sup>nd</sup> Street and the entire perimeter will be surrounded with a decorative fence and monitored with security cameras. The Board raised concerns regarding monitoring of people staying so close to the two schools along with the enforcement of maintaining the luxury facility. Mr. Pynes indicated the City is working on a "specific use" permit and would work closely with the District to ensure all concerned are addressed. If the owner fails to comply with any item in the permit, the business would be required to close. With the anticipated investment in the site, the likelihood of non-compliance would be minimal.

#### **Website Update**

Monty Burger, Chief Technology Officer and Amber Casey, Account Operator/Systems Specialist, presented the Board with a preview of the "New Face of BISD". The new website is designed to be a one stop, attractive resource full of timely information for staff, students and community along with serving as a channel for student and community feedback. It will be easy to navigate and will have a uniform look throughout. Mrs. Casey showed the board a comparison of the old and new and said the ease of use will help it grow with a goal to have all teachers a webpage. Some of the other benefits include offsite hosting which reduces the risk of outages along with Erate eligibility, which makes it affordable. Advanced features including calendars/events, driving directions, forms creator, facebook/twitter banners, job opportunities, school menus, news, sports system and featured spotlight will provide further benefits to users. The site will go live August 15, 2011.
