DECEMBER 9, 2025

Chair Yang called the work study session to order at 6:04 PM with the following present: Director Swor and Superintendent Tucci Osorio. Attending remotely: Chair Yang, Clerk Livingston, Directors Yener, Nitardy, Assistant Superintendents Beaton and St. Michaels, and executive assistant Her. C. Anderson arrived at 6:17 PM.

Others present: Josh Anderson, Director of Finance and Technology

J. Anderson reviewed the fund balance for 2024-2025 and the final levy certification Pay 26.

( C. Anderson arrived during J. Anderson's presentation.)

Board Members reviewed committees and officers for 2025. This is a continued discussion from the November work session and action will be taken at the January 13, 2026 special meeting.

Beaton discussed the following three items: Benefit-Based Accountability, 622 Online Eligibility Criteria, and Naming of 622 AHS.

St. Michaels reviewed the following eleven policies which are proposed for revision: 306 (Code of Ethics and Behaviors); 606 (Textbooks and Instructional Materials); 712 (Video & Electronics Surveillance Other Than On School Transportation Vehicles); 722 (Public Data Request); 417 (Chemical Use & Abuse); 513 (Student Promotion, Retention, and Program Design); 519 (Interviews of Students by Outside Agencies); 601 (School District Curriculum and Instruction Goals); 616 (School District System Accountability); 621 (Literacy and The READ Act); 709 (Student Transportation Safety Policy). The policies will have a formal reading at the December 16 business meeting, followed by an additional reading and proposed action at the January 27 business meeting.

Tucci Osorio gave an immersion update reporting on outreach efforts and the possibility of expanding the Spanish immersion program by adding another section.

During Board check-in, the following items were shared:

- Livingston attended AMSD last Friday where the Stillwater superintendent presented on their cell phone policy which does not allow students to have cell phones in their buildings.

- C. Anderson enjoyed the Elf production put on by Tartan starring several children from the neighborhood.
- Swor attended Delegate Assembly and is excited for her term and these next two years. She looks forward to seeing everyone at MSBA in January.
- Yang will be absent at next week's board meeting and asked the Board to support C. Anderson as he leads the board meeting.
