Bloomingdale School District 13 Remote Learning Survey



June 03, 2020



Overview

The purpose of this survey was to collect stakeholder feedback during these unprecedented times of remote teaching and learning in response to the COVID-19 pandemic. The results will provide district leadership insights to stakeholder perceptions about their experience during the remote learning period and afford opportunities for continuous improvement. The survey is being conducted by ECRA Group, Inc., a third-party research firm.

District employees, students, and parents were surveyed online. Surveys were available in both English and Spanish for students and parents. In all, 427 stakeholders participated. The number of survey participants by stakeholder group is reported in Table 1. Student and parent grade level information is reported in Tables 2 and 3.

The overall level of satisfaction with the continuation of education was rated favorably (satisfied or very satisfied) by 52% of participants. Of all participants, 99% indicated they (or their child) had a device at home for remote learning. Results for each item are reported by stakeholder group. Open-ended comments are reported in the Appendix.

Participants were asked to rate their level of agreement with various statements on a scale of 1 to 5: Strongly Disagree (1), Disagree (2), Neutral (3), Agree (4), and Strongly Agree (5), or their level of satisfaction on a scale of 1 to 5: Very Dissatified (1), Dissatisfied (2), Neutral (3), Satisfied (4), and Very Satisfied (5).
