The New Fairfield Board of Education held a regular meeting on Thursday, September 19, 2019, at 7:00 p.m. in the New Fairfield Community Room, 33 Route 37, New Fairfield, CT.

- **I. CALL TO ORDER:** Chairman Peggy Katkocin called the meeting to order at 7:00 p.m.
- II. PLEDGE OF ALLEGIANCE

III. APPROVAL OF THE MINUTES

VI. BOARD AND ADMINISTRATIVE COMMUNICATIONS

- A. <u>Chairman's Report</u> Peggy Katkocin spoke of the following:
 - Noted that the Grandparents Breakfast at Consolidated School was very nicely done and well attended.
 - Thanked everyone who attended the Public Hearing regarding the proposed building projects held on September 16th. She encouraged anyone that has any questions to speak to either the Superintendent or BOE members.
- B. Superintendent's Report Dr. Pat Cosentino spoke of the following:
 - Thanked Administrators and staff for wonderful Open Houses in all schools.
 - Reminded parents of Consolidated and Middle School students to make sure that their physical reports are turned in.

- Fall sports have begun.
- Substitutes are needed for all schools. Anyone interested can call the Human Resources Department or look on the district website.
- Administrative meetings are held twice a month. Julie Luby led that last meeting regarding "high quality instruction."
- There will be a school wide emergency drill on Wednesday, Sept. 25th.

C. Student Representatives' Report

Senior Representatives Sophia Liguori noted that:

The Senior Barbeque will be held on Wednesday, September 25th immediately following the school wide emergency drill.

D. Committee Report

1. Business Operations/Resource Management - Ed Sbordone noted that this committee met on Sept. 19th and discussed a summary of budget vs. actual numbers for the first two months of the fiscal year. They are in line with the budget. They spoke of Special Education and there are no major concerns. The Building/Facility Use Form will be available on line starting in January.

E. Liaison Report

- 1. Board of Finance Ed Sbordone noted that the BOF met on Tuesday, September 17th and unanimously approved the school project resolution. They met again on September 18th and discussed the BOE surplus for 2018-2019 which is approximately \$207,000. The BOF policy is to give back up to 50% of the surplus. The BOE voted to ask the BOF for 100% of the surplus back. The BOF tabled the approval of this until more information is received. The BOF also reviewed and revised the Town's debt policy and will present this to the BOS next week.
- 2. Parks and Rec Commission Kimberly LaTourette noted that the Parks and Rec Commission is in the process of rescheduling their September meeting.
- 3. Permanent Building Committee Ed Sbordone noted that PBC met on September 10th and reviewed the draft RFQ (Request for Qualifications) if the referendum for the building project were to pass. This will be finalized at the PBC meeting on September 24th. If the referendum passes, the RFQ will go out on October 7th.
- 4. School Security and Safety Committee Samantha Mannion noted that this committee will meet on Wednesday, September 25th at 7:30 p.m. in the Community Room.

VII. INFORMATION ITEMS

A. New Fairfield High School/Consolidated School Building Project Update Dr. Cosentino thanked everyone who came to the Public Hearing regarding the building projects on September 16th. She noted that there will be a Town Meeting on Thursday, September 26th to set the date for the referendum. It is expected to be Saturday, October 5th. She encouraged everyone to vote.

Chairman Peggy Katkocin spoke of the building projects and referenced educational building specifications that were approved by the BOE in June of 2019. This report is available on the Town's website and contains detailed information. She encouraged anyone with questions to check this report.

BOE Member Dominic Cipollone spoke of the process for the building projects and noted that it has been very transparent from the beginning. He asked everyone not to read the negative comments on social media but to rely on the experts for answers to any questions regarding the project.

BOE Member Greg Flanagan spoke of a design for Meeting House Hill School from 2009 and noted it was very similar to the proposed designs for the high school and Consolidated School.

Dr. Cosentino reminded everyone that all facts regarding the project are available on the district website.

B. Superintendent's 2019-2020 Smart Goals and Action Steps

Dr. Cosentino spoke of her Smart goals and action steps. She showed a spreadsheet that highlighted priorities, action steps and Smart Goals. She gave highlights of her goals so that the public knows what she is working on. Some of the highlights include improving student achievement, specifically in the Math department, data analysis, professional development, goals for Special Education studies, school safety, and defining the roles and responsibilities of staff members.

D. New Fairfield High School Graduation 2020

Dr. Cosentino gave a brief description of the process for determining which schools get first choice for using Western Connecticut State University for graduation.

To further recommend to the full Board to direct the administration to investigate an alternative anonymous reporting system if the Sandy Hook Promise Foundation and New Fairfield Public Schools are unable to reach an agreement on changes to the aforementioned MOU and terms of service.
