Re: Resolution to abate taxes levied in 2012 for QZAB Bond Interest

The district sold QZAB bonds in 2010. One of the features of the QZAB bonds is the promise that the IRS will give the district money to pay the interest on the bonds. Today, the district received a check from the IRS for \$120,825 to pay the interest payment due 12/15/2012. In March the Business Office will again request money from the IRS for the interest payment due 6/15/2013.

Since the IRS reimburses the district for the interest payments, it should abate the taxes levied for 2012 for these same interest payments. Therefore, I recommend that the Board approve the attached resolution abating the 2012 tax levy for the QZAB bond interest payments.

WHEREAS, the Board has determined and does hereby determine that the Pledged Revenues (as defined in the Resolution) or other lawfully available funds are available to pay principal of and interest on all outstanding Bonds due in the next Bond Year (June 15 and December 15); and

WHEREAS, such Pledged Revenues or other lawfully available funds have been deposited into the Bond Fund (as defined in the Bond Resolution); and

WHEREAS, it is necessary and in the best interests of the District that the tax heretofore levied for the year 2012 to pay the Bonds be abated:

Section 1. Abatement of Tax. The tax heretofore levied for the year 2012 in the Resolution is hereby abated in its entirety.
